#### □ SEWER I&I PENALTIES, REHABILITATION (Status)

We approved Phase IV of the sewer rehabilitation project (Winshall Drive) at the meeting of July 25th, the cost being \$82,492.50 (work halted at around \$10k). The TV work has revealed we have one for sure, and possibly a second that will need to be excavated to repair. The first is a broken line that's off-set and the second is a "top

down" lead into the main that the connection at the main is crushed. The second may be able to be lined but we must be prepared to excavate if the process fails. We've left the deteriorated areas for now until the ground dries up a bit, in towards summer. This work may get expensive as the mains are in the backyards, which will require the removal of fences and the like in order to get to the problem. To further complicate the matter, one of the problem areas has a garage in our easement, very close to where we have to dig. At any rate, we need to get together a very specific bid package that includes a survey to identify easement lines and encroachments. We also will need to factor in maximum costs for property we may damage, prepare grading permits and waivers of liability. We approved light design engineering, survey and bid package preparation in the amount of \$6,847 at the meeting of February 27th. We'll be back for review and decision as soon as we get the bids back.

As we discussed at the meeting of March 26th, we will enter into a Purchase Agreement that requires Atkinson Construction to demo the building, perform State required due diligence environmental work and obtain an approved due care plan. I met with Marathon Oil and they have agreed to remove the underground storage tanks at their expense. In return, they'll require deed covenants that prohibit future residential use, playgrounds, etc. They will also require the use of a ground vapor barrier under the building. After building demolition and tank removal, we'll close on the property and trust that the developer continues with the project. If they don't, or for reasons unforeseen it fails in the Planning Commission or final Council approval, they'll keep the property and either sell it, sit on it for investment purposes or bring forth another project. The City benefits by getting the property razed and cleaned up and we get our soft costs covered (estimated to be around \$5,000). The property is still held up in Mr. Figura's office while Mr. Parker puts the final Purchase Agreement Draft together. Atkinson Construction is also forming another company to place the property into. The Purchase Agreement should be back at the next meeting for Council approval.

#### ✓ CITY PROPERTY, 4438 MORRISH ROAD (Status)

We'll look at a disposition for the house at 4438 Morrish in the spring.

#### ✓ LABOR CONTRACTS, BUILDING DEPARTMENT (Resolution)

As a short re-cap, all our labor contracts are frozen. The POLC agreement has been frozen since January 2009, AFSCME since July 2008, the Supervisor's since July 2007 and the City Manager's since December 2004. All our union contracts expire on June 30, 2012. As we all know, there are significant changes to labor law that will impact these contracts, if not sooner than later. For the time being, we've opted out of SB #7, the 80% - 20% medical split. I have set this for an executive discussion to review strategy for all our collective bargaining agreements.

We have two other "at will" classifications, being our part time police officers and our building inspector. The part time police have been frozen since March 2004 with a change in November 2009 to allow time and a half on holidays. The building inspector is part time, hired in October 2006 when the position was established to replace the full time assessor / building inspector. We increased the hours and compensation in anticipation of the Meijer Project. I'll be back shortly with an employment agreement for the Building / Code Inspector. Contracted positions are the assessor and trade inspector's, being electrical, plumbing and mechanical. Mr. Zettel remains as a contracted employee handling planning, DDA and assorted related items. We have a few bugs to work out yet, but I think we'll be good with it.

On another matter, our trade inspectors are asking for an increase. We currently pay them \$35 per inspection. The request is \$5, to \$40 per inspection. Here's a snapshot at the budget that depicts revenues and expenses:

As you can see, we have the room for an increase. An informal check shows we are low and that most of the per inspection rates are \$40 or \$50 per inspection. I recommend we approve the increase.

#### ✓ FIRE DEPARTMENT: BOARD, CONTRACT & COST RECOVERY (Status)

At the meeting of March 12th, the Council appointed a three member committee to meet with the Township on the CIF and associated planning issues. We've met once with the Township and it appears the matter may be again stalled. I'll keep the Council posted on changes.

#### ✓ SPRINGBROOK EAST & HERITAGE ASSOCIATION S.A.D. (Resolution)

The final date for full payment was April 2nd. Property owners that did not pay in full will be assessed the cost over five years, beginning with the July tax billings, \$262.37 for Heritage and \$427.10 for Springbrook. The total cost per unit in Springbrook East is \$2,135.50 (64 units) for a total assessment of \$136,672. Heritage Village total is \$1,311.86 per unit (115 units) for a total assessment of \$150,864. We've given this a lot of thought insofar as to best book it. The SAD costs have been paid out of 401 Capital Projects Fund. We recommend the Council back fund this with transfers from 101 General Fund. As collected, the money can be transferred back to the General Fund. The reasons for this are three-fold, one the cost for construction was lower than anticipated, the second, a fair amount has been paid up front, and the third, if we borrow from another fund, we may have to write it in deficit for five years, something I strongly recommend we do not do. At any rate, after the pre-paids, the remaining principal balance exposure to the General Fund is \$70,836.17 for Springbrook East and \$99.829.13 for Heritage Village, for a grand total of \$170,665.30. This will be paid down by \$34,133.06 every summer when it's billed. Bear in mind that this is the principal only and does not include the additional \$7,000+ we will be collecting in interest.

Included with tonight's agenda is a resolution authorizing the final setup of accounts in 401 Capital Projects with transfers in from General Fund to cover the expenses. Every year at budget time, we'll visit whether we transfer the receivables back into the General Fund or sit on them in the 401 Fund. Here are the calculations on what we've received through April 2nd:

#### ✓ SIGN ORDINANCE (Status)

Pending draft changes from the meeting of February 2nd.

#### ✓ SHARED SERVICES INITIATIVE (Status)

We voted this unanimously at the February 13th meeting. Mundy Township voted it the same night with a 6-1 positive vote. Flint Township voted it February 21, unanimous. Not a bad show of support... 20 out of 21. Mr. Nottley has begun work with completion expected in as early as 90 days. I'll keep the Council posted on developments.

#### ✓ SCHOOL PERFORMING ARTS CENTER (Status)

Construction is underway.

#### ✓ STREET RE-STRIPING & SYMBOLS (Status)

Tom is trying to get another round of crack filling into the budget for Miller Road. For the obvious reason, any striping will have to be done after this project. We will be back in a month or two with a recommendation.

#### ✓ MEIJER SITE PLAN & ADDENDUM (Status)

The Council approved an amended site plan allowing for the construction of a gross square foot store of 192,214 along with related changes to parking, traffic circulation, lighting, landscaping, and signage, all of which have been deemed by the City's staff as minor and within the general concept of the original site plan approval. We are in the process of re-negotiating the development agreement with Meijer. On paid-in capital, Meijer funded improvements capped at \$1,500,000. To date, they have paid \$1,095,000. They owe the City \$52,873, which when invoiced and paid, will put their contribution, to date, for the Morrish project at \$1,147,873. This leaves \$352,127 left to fund traffic lights that may or will be needed at the Morrish Road I-69 ramp and at Bristol and Morrish intersection. Progressive AE has begun the collection of traffic data for the design and submittal to MDOT. All shop plans for both structures (store and gas station) have cleared reviews (building, mechanical, HVAC, plumbing and electrical). City water - sewer tap fees and County CCIF fees have been paid. Surface water, IPP and soil - erosion permits have been issued. The only permits left are a Road Commission ROW access for a temporary construction drive on Bristol and the building permit. All that's holding the building permit is for Meijer to give us a cost estimate so we can calculate the fee. We have given them permission to begin mobilization and site excavation work this week. Construction of the building is scheduled to begin with footings in late July.

## **NEW BUSINESS / PROJECTED ISSUES & PROJECTS**

#### ✓ POLICE OFFICER MEMORIAL PROCLAMATION (*Proclamation*)

As the Council is aware, May 15th is the national annual observation memorial day for Police Officer's killed in the line of duty. In honor and recognition of those who have given their life, a proclamation is included with tonight's agenda.

#### ✓ M.E.M.A.C. AGREEMENT (*Resolution*)

Included with tonight's packet is an agreement to participate in the Michigan Emergency Management Assistance Compact (MEMAC). Essentially, this is an agreement with the state for deployment of services, equipment, goods, etc, either to or from the City, in the event of a disaster. The beginning of this is in DC with FEMA and Homeland Security and the end is the local community, such as us. We should have passed this several years ago, which I thought we had, but in checking, I am unable to find it. It's a bit of a house keeping issue that would be of importance if we ever needed to collect disaster relief funding. There are some frequently asked questions at the front of the plan, which can be found on the CD. In line with this, I hope to have a local disaster plan shortly.

#### ✓ ORDINANCE #409, OUIL PENALTIES (Resolution)

Our penalties are out of line with state statute on OUIL and OUID (drunk driving and driving under the influence of drugs) offenses. They have increased by statute and in order to be consistent, we need to move our up. Mr. Gildner has prepared an ordinance that will accomplish this.

#### ✓ PARK FEE WAIVER REQUEST (Resolution)

Included with tonight's program is a request to waive fees for the use of Elms Park Pavilion #2 on Friday May 18th for Cub Scout Pack 122. A resolution for approval is included.

- □ *Traffic Lights, Bristol-Miller, GM-SPO.* Pending the direction that GM takes. New traffic counts as to warrants would need to be taken.

The devices will need some mounting parts that we simply cannot determine without looking at the vehicle. But, for the most part, that is usually minimal, as we always count on some type of pole, base and possibly a support arm. That said you can count on \$350.00 for install labor and approx. \$500.00 in parts (cables, antenna kits, mounting parts) for each install. That means you will probably have between \$850.00 to \$1,000.00 per install.

It is with great pride that I count myself among the men and women of this nation that have chosen to serve and protect our citizens. It is with a greater sense of pride in, and gratitude for, those officers who have paid the ultimate price, that I request the City of Swartz Creek formally recognize and acknowledge the sacrifice of these officers by proclaiming May 15 as Peace Officer's Memorial Day and the week in which that date falls as Police Week. I further request that all City American Flags be lowered and flown at half staff on May 15, 2012 and each May 15 thereafter.



#### Road Commission adopts new 'dark signals' policy

Flint, Michigan. ---

The Genesee County Board of Road Commissioners has adopted a change in its policy regarding the action that the Road Commission will take in the event of a "dark signals" situation. A "dark signal" is a traffic signal that is not lit because of an area-wide power outage.

In order to create uniformity between the Michigan Department of Transportation (MDOT) road system and the Genesee County Road Commission, and to minimize driver confusion, the new policy adopted by the Board of Road Commissioners requires that upon determination that the dark signal is caused by an area-wide power failure, no further action will be taken by the Road Commission. The Road Commission has historically handled "dark signals" by placing temporary stop signs at dark signal intersections until power is restored. It will no longer do so.

In explaining the change, Manager-Director John Daly pointed out that placing STOP signs at any leg of an intersection in this situation could cause driver confusion when the power to the signal comes back on if some signals come back on in the STOP and GO mode. The driver might then be faced with a green signal indication and a STOP sign, and not know which to follow. This would be confusing and might also present a liability.

Placing portable generators at intersections could possibly cause damage to the signal equipment, and might also create a liability if they were placed at one intersection and not another.

Dark Signals Due to Power Outage

To ensure consistent treatment of dark signalized intersections (signal not operating due to local area power outage), the following is a clarification of MDOT policy.

Current maintenance guidelines on dark signals (last revised in 1993) states "An investigation determining that a general power failure is the cause of a problem requires no further action. Placement of portable generators as a temporary power source should not be undertaken. Possible damage to signal equipment may occur. Temporary stop signs may be placed at the intersection and the controller switched to flash operation. After power is restored, the intersection should be switched back to normal operation."

Upon notification of a dark signal, the appropriate region's electrician (or authorized equivalent) should contact the power company to determine if the dark signal is because of a local power outage. If it is determined the power outage is the cause of the dark signal, the following options are available and listed in their preferred order:

- 1. No action taken traffic shall proceed as per the Michigan Vehicle Code, Section 257.649, Right-of-Way; Rules; Violations as Civil Infraction.
- 2. Traffic control is provided by uniformed police officers at the sole discretion and responsibility of the police enforcement agency in a manner determined solely by the police enforcement agency.

3. At signalized intersections under MDOT's jurisdiction (which includes local streets which intersect with trunkline routes), placement of temporary stop signs must be approved by authorized MDOT region/TSC operations staff or by authorized staff of direct maintenance garages or special crews facilities. Reimbursement for work activity by a contract agency would be made.

If a temporary stop sign is placed, the signal <u>must be</u> switched to flash operation with care given to which approaches will be stopping and that they match the colors of the flashing signal once power is restored. Usually under flash operation, the major approaches will flash yellow and the minor approaches flash red. Activating the flash operation requires the electrician maintaining the intersection (or authorized personnel as approved by the appropriate region's electrician) to switch the traffic signal. Without this change in operation, the traffic signal will return to stop and go operation within seconds after power is restored, which could cause conflicts between the signal and any temporary signage (conflicting green or yellow indications with a stop sign for the same approach). If temporary stop signs are placed, they shall be continuously monitored by the local agency to insure removal upon restoration of power. At that time, the signal must be switched back to the normal stop and go mode of operation by MDOT forces or authorized personnel. If it cannot be ensured that the signal will come back in the appropriate flash mode in conjunction with the temporary traffic control, stop signs shall not be placed at the intersection.

As was stated earlier, placement of a portable generator as a temporary power source should not be undertaken. However, contract maintaining agencies that have extensive knowledge and experience with traffic signals can request prior written approval from MDOT to use generators. As part of the request, the maintaining agency will need to identify how they will prioritize generator placement during area wide power outages. The request will then need to be reviewed by appropriate MDOT personnel before authorization is given.

# King of the landfill: No one recycles more trash than Swartz Creek

GENESEE COUNTY, MI -- In the world of curbside recycling, it turns out size does matter.

Much bigger recycling bins on wheels that have been rolled out in Swartz Creek are being credited for boosting the city's recycling rate to 18.4 percent -- easily the best in the county, according to a new report by the county Planning Commission.

"We had these little recycling bins and then we went to a 95-gallon container," said City Manager Paul Bueche.
"From my own personal use, what I recycle has increased significantly -- probably two or three times as much."

Swartz Creek's success was highlighted in the new county report, which was presented to the Planning Commission earlier this month.

City residents are given two 95-gallon waste containers -- one for garbage and one for recycling -- but aren't restricted from using their own containers if they run

out of room for trash.

Only two other cities in the county -- Fenton at 10.9 percent and Grand Blanc at 14.4 percent -- are diverting more than 10 percent of residential waste through recycling. Grand Blanc Township -- 13 percent -- was the only township in the county to achieve that level of recycling, the report says.

"Bigger bins allow (people) to put more recyclables in a container," said Ann Marie Kerby, an associate planner for the county. "It's convenience. A lot of people end up throwing a lot of stuff away because they don't have" enough room in smaller bins.

In Davison, **recycling rates jumped dramatically** last May when Republic
Services Inc., which handles the city's
trash pickup, expanded a pilot program
with bigger recycling bins.

City Councilman Paul Hammond, who lives in an area that piloted the program in Davison, credits it with boosting Davison's curbside program.

"It's a roaring success," Hammond said.
"It's much more convenient and we don't have to segregate materials. They take it and sort this stuff out."

In a survey that's included in the new report, 23 percent of county residents questioned in February and March suggested larger or extra bins as the top way to improve curbside recycling followed by providing more information on hazardous waste (18 percent), and providing more general information or education for those who don't recycle (13 percent).

Bin size isn't the only factor that's creating higher recycling rates, officials said.

Communities with reward programs for recycling, giving customer discounts and deals at local businesses, have increased

recycling, according to the county.

Grand Blanc Township, which has had a reward program for more than two years, keeps an average of 63,000 pounds of waste from the landfill weekly as a result of its curbside program, according to the report.

"Every person who moves in wants to be involved," township Supervisor Micki Hoffman said.

The county report is also suggesting communities "explore the benefits of implementing pay-as you-throw collection system in which residents are charged for waste collection based on how much they are throwing away.

The city of Fenton is the only community using that type of program currently.

The area with the lowest recycling rate in the county -- the city of Flint -- is the only community in the county with no curbside recycling program. The city of Mt. Morris and village of Otisville also had recycling rates of less than 1 percent in the report.

The county report says more than 65 million pounds of waste are unnecessarily being dumped in a landfill as a result.

"The city of Flint makes up nearly a quarter of the population in Genesee County and is behind the times by not offering recycling to its residents," the report says. "Currently we estimate that roughly 5 percent of households in the city of Flint are participating in a residential recycling program.

"With ... a recycling program, backed by a resident education program, the county participation average ... could easily be attainable."
