# **OLD / ROUTINE BUSINESS – REVISITED ISSUES / PROJECTS**

# ✓ GOLF COURSE TAX APPEAL (Update)

The owner's legal representative is moving through the process to withdraw this appeal. It appears they may have been dragged into this against their will by the prior owner. However, until we have notice that they have officially withdrawn, we must assume they intend to see the appeal through. Unfortunately, this means we may need to spend funds on an appraisal.

## ✓ **RACEWAY STATUS – AGENDA ITEM (Update)**

I have been informed that the Sports Creek Raceway is officially closed and is for sale. They are already in the process of liquidating assets.

Our community will forego \$44,000 of general fund revenues annually moving forward.

This tax appeal is still out there as well. They are requesting a true cash value of \$500,000. The asking price is reportedly "a couple million."

One way or another, they still have 108.5 acres at a signalized intersection with I-69. Their appeal information is as follows:

2014 Taxable: \$904,200 2014 Taxable (requested): \$250,000

Whether the tax appeal flies or a sale ensues immediately, it is clear that this site will need to be repurposed. Perhaps more pressing is the consideration of ways in which the city could help assist with the reuse or redevelopment of this site in a way that benefits our town. The site is currently zoned industrial to accommodate the raceway. It is probably in the city's best interest to zone this commercial to achieve the highest and best use, as well as a use that is not detrimental to surrounding properties. I will run this by the planning commission at their next meeting.

I have reached out to the manager of the site to offer any planning, zoning, informational, or other assistance that we can offer. For the time being, it is prudent to zone the site to something that complements our community and the master plan. Currently the site is zoned industrial. Since this interchange is planned for regional retail, hospitality, and related General Business District (GBD) uses, I recommend the planning commission review the site to see if a change to GBD or another zoning classification is appropriate. A resolution to do so is included.

#### ✓ DOWNTOWN PARKING LOTS (No Change of Status) The trees are in. Now we await the light installation and fences.

#### ✓ **STREETS** (See Individual Category)

#### □ MILLER ROAD RESURFACING PROJECT (No Change of Status)

The grade inspection for Miller Road, between Morrish and Dye, was held on November 5, 2014. The project is moving forward as planned, with some modifications and other design exceptions as described by Mr. Warren at our meeting on December 8th. The date set by the state for construction commencement was June 1, 2015, with completion on August 28, 2015. This is just a tentative schedule.

#### □ LOCAL STREET PLAN – AGENDA ITEM (Update)

I have draft ballot language prepared as follows:

2015 Ballot Proposal

City of Swartz Creek Road Improvement Millage Proposal

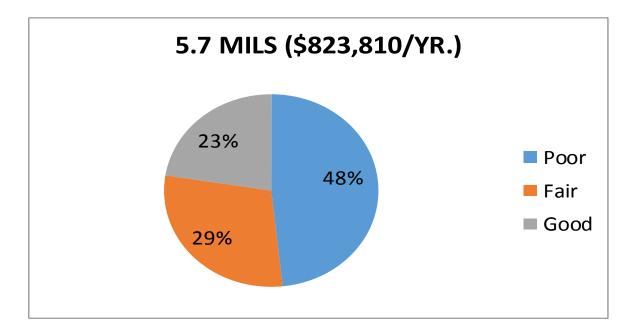
Shall the City of Swartz Creek be authorized to levy a millage of up to a maximum of 5.7 mills (\$5.70 Per \$1,000 of taxable value) for a twenty (20) years, 2015-2034, inclusive, for the purpose of funding construction and interest costs for the replacement, rehabilitation, repair, and maintenance of public streets and include pavement, sidewalk, curb, gutter, shoulders, and related drainage work within the City of Swartz Creek, the estimated revenues that will be collected during the first year of this millage as authorized and levied to be \$823,810 for the major street and local street funds?

The street committee has met twice on this issue. In short, we know that there is no practical way to ask the voters to contribute what best practice indicates we should be levying. This amount is over 9 mils for a period of twenty years.

With that said, the committee chose to seek approval of an amount that appears to be affordable based upon input received over the last 18 months from the public. The committee felt that, for a typical house in Winchester Village, \$15-\$16 a month (just under \$200 a year) was a reasonable ask. The levy that reflects this on a home with a taxable value of \$35,000 (assessed at \$70,000) is 5.700 mils.

The following represents the twenty year level of service at 5.7 mils:

To complicate matters, the state legislature chose not to solve the road problem on their own. There is now a proposal on the same May ballot to increase the state sales tax as a way to raise funds for streets. Unfortunately, we do not know if this will be successful or to what degree funds would trickle down to local streets even if it is. We met on this complication. The recommendation is to continue with the plan as proposed. If both taxes are successful, the council can lower the local levy. If the local levy passes and the state levy fails, we succeed with plan A. If the local levy fails and the state tax passes, we can try again to pass a lower levy amount to make up the difference at a future meeting.

There was consideration given to alternate ballot language that would make the amount contingent upon the state sales tax vote. However, this would be difficult to operationalize, especially since the impact is still unknown. It would also likely result in further confusion.

The committee believes that a strong public education component will be needed to inform the public about the costs and benefits of this levy and plan. They request that the council retain the committee and direct it to develop a plan that prioritizes the street treatments and illustrates a full 20 year initial action plan. I think this is the component that has been missing in the past and agree that a full action plan would better illustrate the value of a street plan.

# SCRAP TIRE GRANT (No Change of Status)

We submitted a placeholder application for another round of funding. This way, if a street levy/assessment is approved, we can begin construction in 2015 instead of 2016 and potentially save \$500,000 in the process. However, the state requested we resubmit the proposal for a lesser amount to reflect 4x higher demand for grant funds over what is available. The projects tentatively scheduled include:

Because of the loss in scrap tire grant availability, the city will have to wait for bids to come in and make tough decisions regarding the trimming of the project, the allocation of general fund dollars, or the delay of some street work. For the time being, we want to keep our foot in the door on any funds available.

#### ✓ WATER – SEWER ISSUES PENDING (See Individual Category)

#### SEWER REHABILITATION PROGRAM – AGENDA ITEM (Update)

Liqui Force intends to present their findings from the current year projects, including lining work and televising/inspection work this Monday. We should have a draft capital improvement plan for sewer that includes five years of detailed work plans and fifteen additional years of generalized work plans that will cover the entire system. Our intention is to inspect and make repairs over the entire system in twenty years.

#### □ BEAR CREEK SANITARY SEWER AGREEMENT (No Change of Status) Gaines has new leadership. We await their response to the city approval.

#### **KWA** (No Change of Status)

The KWA water pipeline project is currently under budget and on schedule. We should be online in 2016.

#### **STORM SEWER** (No Change of Status)

The ordinances are approved. We await final approval from the state regarding our National Pollutant Discharge Elimination System (NPDES) permit. Recently, Mr. Svrcek has been networking with other communities in Genesee County about future expectations of the NPDES permit and common problems. We may investigate new partnerships for permitting instead of using the county.

#### □ WATER LOSS (Update)

We have been auditing accounts and upgrading large customer meters, including General Motors. One large retail customer was found to have a billing error that will account for some of the water loss. Unfortunately, what we are finding is that the loss is more comparable to a thousand paper cuts than a nick to a large artery. So, while we are making progress, we don't expect to solve the loss by changing one bad meter or finding a large leak.

We have also discovered that there was water entering (but not leaving) the water tower. This tower was supposed to be sealed off with a closed valve. We have double-valved the water tower off from the system, with the intention of physically disconnecting it this summer. The water that we drained would have contributed to substantial water loss (over 40,000 cubic feet if full).

Another step we are taking is to meter water usage for the Swartz Creek Area Fire Department. We intended to monitor the use this summer and plan to bill for the usage in the next fiscal year.

#### □ WATER RATES (Update)

We just received notice that water rates are going up again as a result of DWSD contract issues. The impact on the city will be approximately \$87,000 annually. The rate will begin impacting us in March, and we anticipate another rate increase from the county in July.

We have budgeted about \$185,000 in excess of regular operating costs for the purpose of capital investment on an annual basis. This means that we can absorb the rate increase without compromising operations. However, our ability to sustainably invest in the old system with projects such as that proposed for Worchester would be severely compromised.

Given the timing and scale of the recent increases to our customers, I recommend we absorb this increase until we know what is happening in July. At that point, we can evaluate the new rate structure and compare it to our strategic operating and investment goals.

On the bright side, the Karegnondi Authority should be selling us water by 2016. I expect stable rates at that time. We may even benefit from a rate decrease judging by the rapid ascent of rates from Detroit.

#### ✓ **PERSONNEL: POLICIES & PROCEDURES** (No Change of Status)

I have taken some best practice polices from our own collection and from across the state and have created a working document. I will need time to compare this against our collective bargaining agreements, the desires of department heads, and our legal counsel.

## ✓ 5017 THIRD STREET (Update)

The planning commission will review this property at their regular meeting on February 3rd.

#### ✓ 4438 MORRISH ROAD (No Change of Status)

At the first December meeting, the DDA presented findings to the council and sought permission to move forward with formally exploring the development of the parcel. The council continued the decision until after the New Year. I will bring their request back at

that time. If council members can convey their individual concerns and questions at this meeting, or to me directly, I will be better prepared to discuss these. A summary of the efforts so far follows.

At the November DDA meeting, an architect presented some conceptual options that they believe are possible from a market and physical standpoint. They believe this site is well suited for dense housing. They believe that a commercial component may be feasible on the corner of Morrish, due to higher exposure and access, but they do not believe office, retail, or other commercial uses would work on Fortino Drive.

In accordance with the DDA vision and prior recommendations by market consultants (Anderson Economic Group), the DDA agrees with this assessment. New housing would bring residents downtown, adding disposable income, tax base, social capital, and positive branding (image building). The housing proposed, likely to be townhouse style, is also more practical from a market standpoint because it is not as risky as commercial space or low density housing options. Again, this is all conceptual only! This plan is intended to present a visual of what the site COULD look like if developed. It is not intended to reflect proposed traffic patterns, density, or even use. It also does not preclude the movement of Fortino Drive or the inclusion of public components, such as parking.

The DDA is really just asking the question: will the city council consider a development of some type here, or is the land slated to be used for another purpose? If interested, the DDA will engage professionals, at their expense, to explore options and test the function and marketability of such options. Based upon my work with the DDA and the current circumstances, I believe this is the right course and support the concept.

Ultimately, the city council would have final say over any sale and any site plan that is approved.

#### ✓ SHARED SERVICES, POLICE DEPARTMENTS (Update)

Presently, our respective communities plan to swear in each other's officers. This is a common practice that is already in effect between the City of Swartz Creek and Genesee County. It enables officers of both departments to work in both communities with the full force of the law, allowing each department to become familiar with the other department's area, operations, personnel, laws, etc. There is no increased liability, nor is there a change in command structure. The officers still work for their own departments, but they can legally assist each other without an official request through 911.

The oath will be temporary, expiring at the end of 2015. The intent is to learn more about each department and best gauge how a merged department might operate, including potential patrol districts, supervision duties, and organizational culture.

The chiefs plan to hold a joint ceremony on January 14<sup>th</sup> to accomplish this. The ceremony is going to be at 6:00 p.m. in the Performing Arts Center, and all council members are encouraged to attend.

In addition to the oath of office for our officers, there will also be a departmental meeting to begin forming committee assignments with the officers in order to develop effective planning for the future potential consolidation of the two departments.

#### SPRINGBROOK EAST & HERITAGE VACANT LOTS (No Change of Status) Following are issues pending for the three Associations:

Three units have sold in Springbrook East and are under construction. At some point next year, the city council should look at what to do with the funds in excess of the city's input that we are getting for these units.

## ✓ MEIJER COMMUNITY DONATION (Update)

I have contacted Meijer, and they definitely wish to have a public event to commemorate their contribution to the community. Perhaps a recognition of their donation along the Veteran's walk on Fortino would be appropriate during Memorial Day.

#### ✓ WINCHESTER WOODS LOTS (No Change of Status)

Tom and I have taken a harder look at the development of this area. Previously, the city considered an assessment that would provide drainage, curbs, gutters, road construction, street lights and sidewalks. The price per lot was absurd (over \$30,000 per lot). What we have found over the years is that the desirability of the area is large based upon its rustic feel. In fact, the asphalt millings used on the road are garnering much praise from the residents.

I think the goal should be to make these lots buildable for quality homes. The city could probably achieve this with less intensive ditching and surfacing of the roads, sans the underground drainage system, lights, curbs, and sidewalks. This would drastically reduce the scope of the project.

Tom may begin the process of using our crews to place asphalt millings on the twotrack paths in the coming months (years), as well as working on ditching/drainage. Since most (but not all) underground utilities are in place, we may be able to enable lot sales in the near future without much capital investment.

Concerning the city-owned lots. I suggest we hold on to these for a few reasons. 1. We may need them to make the large area usable, by providing drainage transportation or detention. 2. There is no value to speak of at this point. 3. A sale of lots to an adjacent property owner could compromise the success of any special assessment for improvements and the ability to use these lots for single family homes.

#### ✓ **NEWSLETTER** (*No Change of Status*)

# ✓ CONSUMERS ENERGY STREET LIGHT AUDIT – AGENDA ITEM (Update)

Our attorney sees no harm in approving the new contracts at the lower rate. We can do so immediately and hold off on the rebate. This will allow us to realize ongoing savings without compromising our ability to further negotiate the refund we are expecting due to contractual overpayments.

Just to be clear, there are two sets of documents at work here. One is an acknowledgement of the refund and the other is the recognition of a revised service contract that is significantly cheaper. They function independently. I have prepared a resolution to approve the street lighting contract only.

We have an intern performing a field audit on the contract as it relates to referenced lights on our street network. This is in process. Errors can be adjusted and reflected on the current contract anytime.

I have also written to Consumers to request formal dialogue on the refund issue. At some point, we may have to cut our losses. I say this because it will be difficult and expensive to objectively demonstrate past use of the lighting system, as well as to carry on a legal dispute with a public utility.

#### The original report follows:

Consumers Energy has been performing an audit for quite a long time. I don't know how long since I was not here, but I suspect it has been years. What they were doing, literally, was inspecting the entire city system and comparing the number, location, and type of fixtures observed in the field with what is on our street lighting contract. I have attached their findings.

The bottom line is that our city has been overbilled by ~15% annually, mostly due to light classification as opposed to light count. Lower bills and a credit are on the way, which is good. However, since the Michigan Public Service Commission (MPSC) only permits overbilling corrections to span three years, we have been fleeced pretty good overall. To take it a step further, the mistakes made certainly appear to be more than one or two data entry errors or 'oops' moments by those in the field. For example, our prior bill had us on for seventy-six 700 watt mercury vapor. As it turns out, we had zero. The much cheaper 250 watt HPS were under billed by ninety-four. The 100 watt HPS were also substantially under billed.

Don't get me wrong. I generally enjoy working with Consumers Energy, but such broad sweeping 'upgrading' of the fixtures on the lighting contract seems somewhat strange. Every time Consumers changed a bulb, their electric demand dropped, but they never (or seldom) altered our bill. I inquired of the matter on the city manager's email list serve to see what other communities were experiencing, and we are not alone.

So, what now? We can be thankful that an audit was done, sign the new agreements, take the credit, and pay lower bills. -OR- We can look to further negotiate the return of overpayments extending back beyond three years, either as a single entity or as a collective of cities capable of stronger legal action. I am making more legal inquiries now to ascertain the probability of further negotiating or otherwise being awarded a larger judgment by the MPSC.

What is at stake? Each month that we delay, we could be losing \$1,500 in general fund money by not entering into the new contracts, and issues like this are seldom resolved quickly. What is there to gain? That is hard to say. It depends on how long ago the changes to our system were made in the field. If the HPS were installed three years ago, there isn't much to gain at all and we should dive into the new agreements. If they were installed 20 years ago, there could be a half million dollars of general fund money at stake (depending on inflation and applicable interest).

If the council wishes to put this behind us, there are immediate savings to be had. My experience with Consumers and MPSC lead me to believe that this is the ultimate result we will be forced to live with (think of the Bristol Road project and the Verizon bill). However, I would be remiss to encourage a quick execution of this agreement if we lose our ability to get back previous overcharges that the community may be entitled to.

I will continue to make inquiries with other communities, our legal counsel, and the Michigan Municipal League.

## ✓ RENTAL REGISTRATION AND INSPECTIONS (Update)

It looks like the legislature will leave rental registration alone. I am working on the last of the administrative forms and scoring sheets that would be used in the inspection process. Once this is complete, I will forward these to the council for review with the ordinance.

### ✓ **FAIRCHILD AND MILLER INTERSECTION LIGHTS** (No Change of Status)

Without consultation or affirmation of our request, we received a right-of-way permit from Consumers Energy to place two street lights at the corner of Fairchild and Miller Road. This came in on November 10<sup>th</sup>. I am not sure what the holdup was in the past, but I can guess why action is being taken now. Either way, we will move forward and look forward to the installation of those lights.

# ✓ OTHER COMMUNICATIONS & HAPPENINGS (Update)

#### MONTHLY REPORTS (Update)

The monthly check run, FANG report, DPW report, and police reports are included, along with a Consumers Energy rate change notice.

CN has sent notice to the city regarding hazardous materials that are shipped through the area. I am working with Brent to assess our preparedness and vulnerability.

# ✓ BOARDS & COMMISSIONS (See Individual Category)

#### □ PLANNING COMMISSION (Update)

The Marathon site (Biggby Coffee) was reviewed at the December 2, 2014 meeting. The proposal included a Biggby Coffee and Subway restaurant, both with separate drive through facilities. The site has many noted issues related to parking, drive through function, and traffic. The planning commission continued the review in order for the petitioner to complete and submit a traffic impact assessment. There has not been any more progress on this plan, so the January meeting was cancelled. We have received a notice to proceed with the review at the February 3<sup>rd</sup> meeting. I do not know if the petitioner will submit site plan changes or a traffic assessment as required by the planning commission and zoning ordinance.

### DOWNTOWN DEVELOPMENT AUTHORITY (Update)

They met January 8<sup>th</sup> to go over the waiver option on the street levy and to discuss the Morrish/Fortino property. The waiver was approved. I will be working with the council in the coming weeks and months on the vacant land issue to attempt to resolve issues with parking and the Fortino/Morrish intersection.

#### □ ZONING BOARD OF APPEALS (Update)

They met on December 17<sup>th</sup> to hear variances related to the Biggby Coffee proposal (parking/stacking shortage among others). These variances were conditionally approved. However, the site plan must still be approved by the planning commission and city council. The outstanding issue is site access and the related traffic assessment/study.

#### **PARKS AND RECREATION COMMISSION** (No Change of Status)

The commission affirmed the scope of the Recreation Passport Grant. They have tentatively approved a scope for the grant work which follows:

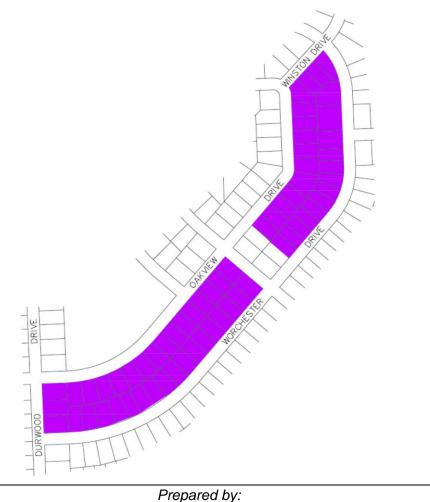

## 1. COMPLETED WORK –

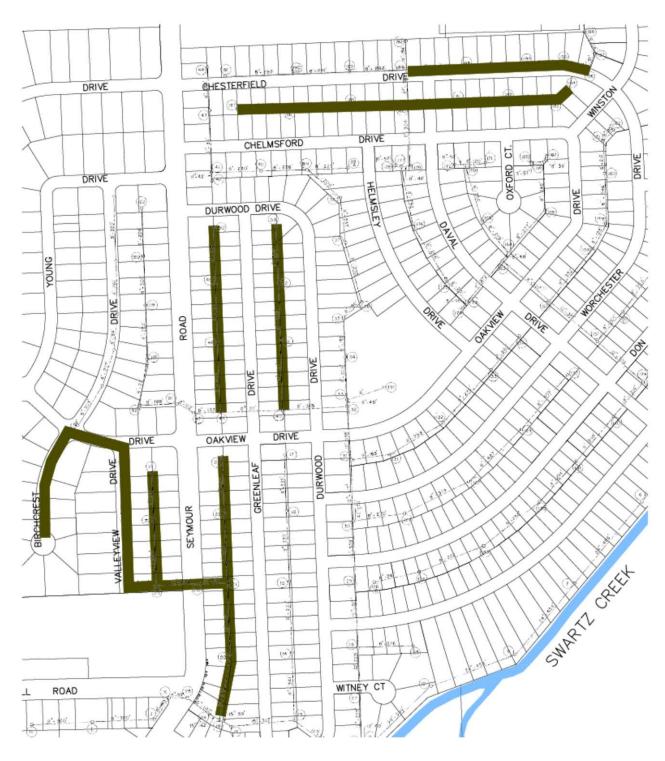
- Winchester Village has been the priority for all rehabilitation efforts; a majority of the collection system in this area was constructed in the rear yards making pipe replacement very costly.

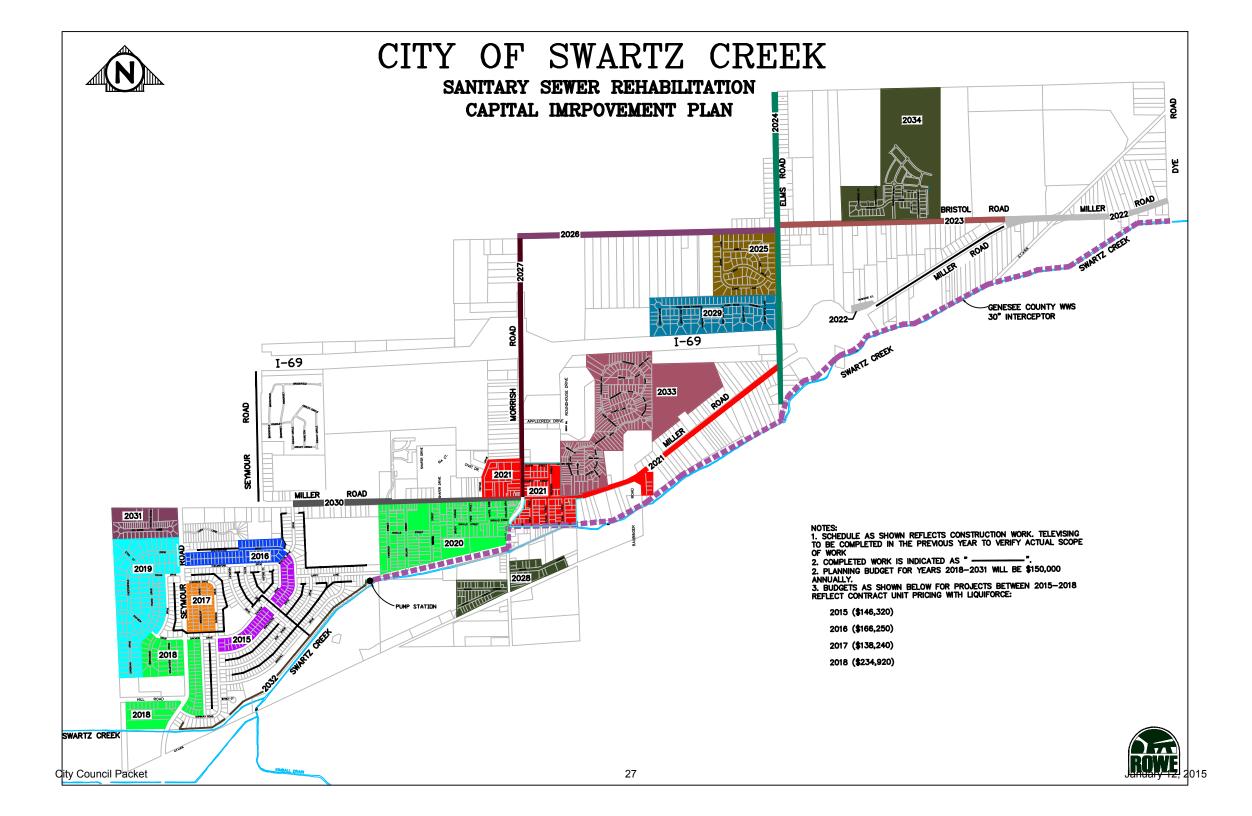

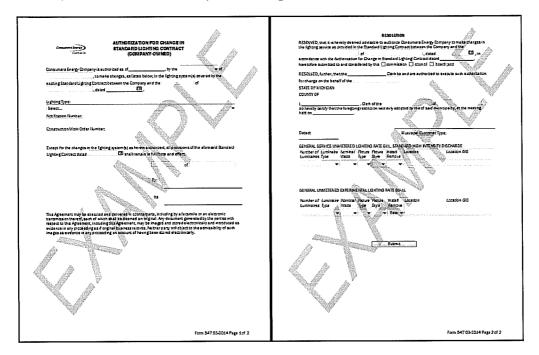

#### **Standard Lighting Contract Terms and Conditions**

1. The Company agrees to furnish the Customer with lighting service respecting the luminaires, lamps and other equipment constituting the installation(s) listed in Part I and also to furnish lighting service respecting any additional luminaires, lamps and other equipment to be installed hereunder as may be authorized by the Customer through execution of an Authorization for Change in Standard Lighting Contract, attached to and made a part of this Agreement as Form 547.



- 2. The Company's service lines necessary to supply the energy for said lighting equipment shall be constructed in the public streets and highways of the Customer, or on private property, as mutually agreed between the Company and the Customer. In cases where such lines are to be constructed upon private property, the Customer shall obtain and furnish to the Company adequate written easements granting permission to install and maintain such lines.
- 3. Neither party shall be liable to the other for damages for any act, omission or circumstance occasioned by or in consequence of any act of God, labor disturbance, act of the public enemy, war, insurrection, riot, fire, storm or flood, explosion, breakage or accident to machinery or equipment, or by any other cause or causes beyond such party's control, including any curtailment, order, regulation or restriction imposed by governmental, military or lawfully established civilian authorities, or by the making of necessary repairs upon the property or equipment of either party hereto; provided, however, that the Company's responsibility for interruptions in service, phase failure or reversal, or variations in the service characteristics shall be as provided in the Company's Electric Rate Book as filed with and approved by the Michigan Public Service Commission and such amendments thereof as may be filed with and approved by the Michigan Public Service Commission from time to time. A copy of said Electric Rate Book will be furnished to the Customer upon request.
- 4. The Customer shall pay the Company for the lighting service herein provided for in accordance with the Company's applicable lighting rate, and in accordance with such revisions and amendments thereof, supplements thereto, or substitutions therefor as may be filed with and approved by the Michigan Public Service Commission from time to time
- 5. The Company shall render to the Customer, as soon as possible after the first day of each month, a bill for all lighting service furnished hereunder during the preceding month. Such bills shall be due and payable within twenty-one days after their issuance
- 6. The Company agrees to furnish a service for lighting and the Customer agrees to take service for lighting in accordance with the terms and conditions of the Company's General Service Unmetered Lighting Rate GUL and General Unmetered Experimental Lighting Rate GU-XL in accordance with such City revisions and amendments thereof, supplements thereto, or substitutions therefore as may be filed to with and approved by the Michigan Public Service Commission.

- 7. Further, the Company will, under the terms and conditions hereof and of the Company's General Service Unmetered Lighting Rate GUL and General Unmetered Experimental Lighting Rate GU-XL and such revisions and amendments thereof, supplements thereto, or substitutions therefor as may be filed with and approved by the Michigan Public Service Commission from time to time and at such locations as may be authorized by the Customer through execution of an Authorization for Change in Standard Lighting Contract (Form 547), relocate any lighting equipment which is included in the initial Company-owned installation or in the additional Company-owned lighting equipment identified in Part I, provided that:
  - a. Upon relocation of any of such lighting equipment, the Customer shall reimburse the Company for the Company's actual costs of such relocation regardless of the time period that such equipment has been installed, and
  - b. The relocated equipment shall conform with the provisions in such application rates
- 8. In addition, the Company will, upon termination of this Agreement by the Customer or breach of this Agreement by the Customer resulting in termination of this Agreement, remove all of the aforesaid Company-owned lighting equipment which is then installed and not thereupon covered by another lighting contract. 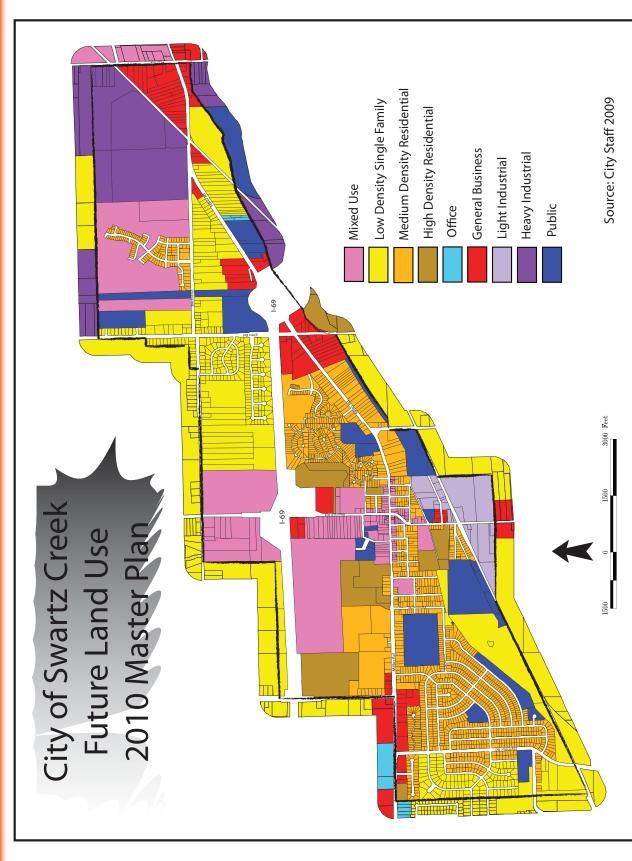

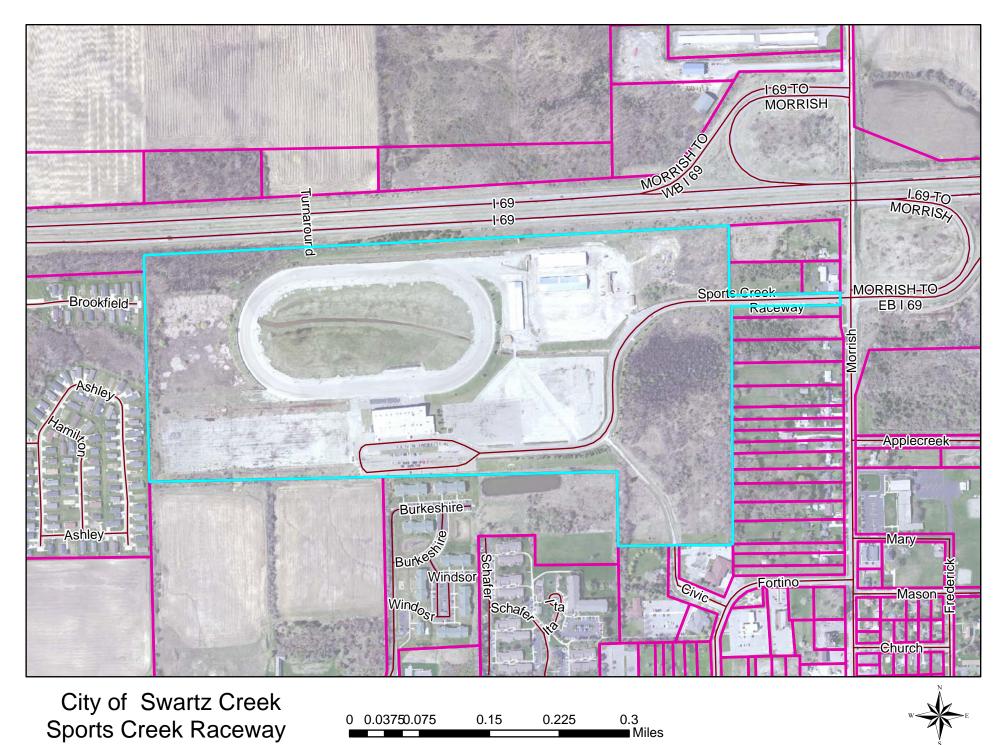
FUTURE LAND USE MAP

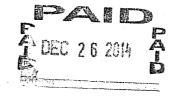

Dear Ms. Aguilar:

On December 12, 2014, we received notice from the Director of DWSD that she was going to recommend, to the Detroit Water Board, a rate increase to the Genesee County water and wastewater system. This rate increase, in our opinion, is in retaliation to a breakdown in negotiations for a short-term/long-term agreement between GCDC and DWSD.

While we disagree with the proposed rate increase, we need to be prepared to collect those fees from our customers. To that end, the Advisory Board members, on December 17, recommended the Drain Commissioner establish a rate sufficient to cover the added cost.

Find enclosed a water rate sheet to become effective March 2, 2015. The only change to the sheet is the commodity rate from \$4.45 to \$4.75 per 100 cubic feet. The 30 cents per 100 cubic feet increase for the average customer equates to approximately \$3.00 per month or \$36.00 per year.

The County will begin collecting the money on all bills issued after March 2. The funds will go towards the excess charges. If no excess charges are applied, the revenues will be used to offset the annual rate increase that is applied in July of each year from DWSD.

Last year, the Division absorbed the DWSD rate increase from April through August of 2014, when we saw three rate changes in a three month period from DWSD. The estimated monthly increase for your community is \$7,220.53, should you choose to hold off and absorb the rate increase until July or August of 2015.

The rate will become effective on all water bills issued by the County Agency after March 2, 2015.

Once the rate increase is approved by each local community, our retail customers need to give us 20 days' notice of rate change. If you would like your rate change to be effective March 2, we need notification by February 15, 2015. As always, our office is available to assist you in adjusting your water rates to cover the increase.

Should you have any questions or need further comments, do not hesitate to contact this office.

Dear Chief Cole:

The safe transportation of hazardous materials by rail is a key priority for communities throughout North America and for the rail industry. In recent months, community concerns have been heighted due to incidents in Canada and the United States involving crude oil shipments by rail. CN has been receiving questions and comments about our safety practices involving the movement of hazardous materials by rail through communities.

We are proud of CN's safety record and of our safety management systems that we use to ensure safety remains top-of-mind for our employees. CN's safety performance is strong and we continue to work to further strengthen safety. If an accident does occur, we have the training, technology, and resources needed to take prompt action and conduct any necessary remediation.

We also recognize that we have a responsibility to ensure that the communities in which we operate have the information they need to ensure the safety of their citizens. They need to know the types of hazardous materials that move through their jurisdictions, to ensure their emergency responders have the information and training they need to respond to any rail accident that may occur. In addition, CN's Dangerous Goods group has been reaching out to communities across our network for years, sharing information on hazardous materials movements and offering assistance for emergency response training.

Please see below for the December monthly activity report:

On 12-1-14, FANG officers performed a knock and talk at a suspected methamphetamine lab in Flint Twp. Officers had received information a suspect had purchased methamphetamine components and was planning on cooking methamphetamine. Officers made contact with the suspect and received consent to search. All components to perform a methamphetamine one pot cook were seized from the residence. The suspect was lodged in the Genesee County Jail.

On 12-1-14, FANG officers conducted surveillance on a suspected heroin house in the city of Flint. A vehicle was observed arriving and leaving the residence. After observing traffic violations a traffic stop was requested by FANG. The vehicle was stopped by uniform MSP Troopers. One subject was found to have warrants for violation of probation and was lodged in the Genesee County Jail. Another passenger was found to be in possession of heroin. The investigation is on-going.

On 12-1-14, FANG officers performed a controlled purchase of heroin from a suspect in the city of Flint. The investigation is on-going.

On 12-2-15, FANG officers conducted surveillance on a suspected heroin house in Flint Twp. After observing the suspect leave the residence officers conducted surveillance on the suspects as they travelled to a gas station. Officers observed what appeared to be a drug transaction. The suspected "buyer" was followed away from the gas station. After observing motor vehicle code violations a traffic stop was conducted by a MSP Trooper. The occupants were found to be in possession of heroin and cooperated with officers. This information was used to obtain and execute a search warrant at the residence in Flint Twp. on 12-3-15. While conducting surveillance prior to executing the search warrant the suspect vehicle was observed leaving the residence. A MSP Trooper initiated a traffic stop, the vehicle initially stopped, however sped off as officers approached the vehicle. After a short pursuit the driver lost control coming to rest in the yard of a residence. The driver attempted to flee, however was captured before he could get out of his vehicle. The driver was found to have ten bindles of heroin on his person. During a search of the residence officers seized 8 grams of heroin, and a quantity of prescription Zanex pills. Forfeiture proceeding s were initiated on \$315.00. 4 subjects were lodged at the Flint City Jail.

On 12-2-14, FANG officers obtained and executed a search warrant at a residence in the city of Flint. This being the result of previous controlled purchases of heroin from the suspect at other locations. Officers seized 4 grams of marijuana and initiated forfeiture proceedings on \$900.00 and a 2011 Dodge Challenger.

On 12-4-14, FANG officers conducted a controlled purchase of crack cocaine from a suspect in the city of Flint. The investigation is on-going.

On 12-5-14, methamphetamine response trained FANG officers performed a methamphetamine awareness/investigation presentation for a high school forensic class at Montrose High School.

On 12-8-14, FANG officers observed a subject known to FANG to sell narcotics in the city of Flint. Officers observed the suspect as he pulled out of his driveway. After observing violations of the motor vehicle code a traffic stop was conducted by a MSP Trooper. Subsequent contact with the

occupants revealed the driver had given his 15 year old passenger a bindle of crack cocaine and two crack pipes to conceal during the traffic stop. Officers then obtained and executed a search warrant at the suspect's residence in the city of Flint. Officers seized 9 grams of crack cocaine and 7 grams of marijuana. Forfeiture proceedings were initiated on \$395.00. The suspect was lodged at the Genesee County Jail.

On 12-9-14, FANG offices performed an undercover officer buy of heroin from a suspect in the city of Flint. The investigation is on-going.

On 12-11-14, FANG officers executed a search warrant at a residence in the City of Flint. The male suspect was arrested on 3 outstanding warrants out of the 68<sup>th</sup> District Court and was a convicted Felon. Seized from the home was 4 grams of cocaine, 2 grams of crack and a stolen 5.56mm handgun from Mt. Morris Twp. The male was lodged in the Genesee County Jail.

On 12-15-14, FANG officers conducted a knock and talk at a residence in Mt Morris Township. Officers were there to investigate possible drug activity at the home. Drug paraphernalia was located in the home but no drugs were found. A female inside was arrested on a Felony Warrant for home invasion and a male was arrested on a misdemeanor assault warrant. Both subjects were lodged at the Flint City lock up.

On 12-15-14, FANG officers executed a search warrant at a residence on the south side of Flint. Seized from the home was approximately 13 grams of cocaine and .45 caliber ammunition. The male suspect was a convicted Felon and lodged in the Genesee County Jail on fresh PWID charges.

On 12-15-14, FANG officers conducted a consent search at a residence in the City of Burton. Officers seized 36 grams of Marijuana packaged in (25) individual bags. The male suspect was arrested for PWID marijuana and released pending further investigation.

On 12-15-14, FANG officers conducted a controlled purchase of heroin using a Confidential Informant (CI). The CI met with a known drug dealer in a driveway on the east side of Flint. The CI purchased heroin from the suspect. FANG officers conducted surveillance and gathered intelligence on the suspect. The investigation is still on going.

On 12-16-14, FANG officers conducted a consent search at a residence in Mt Morris Township. Officers discovered a marijuana grow op in the storm cellar and in the upstairs of the home. Officers seized (14) marijuana plants and approximately 1 pound of processed marijuana. The male suspect was released pending further investigation.

On 12-17-14, FANG officers were conducting surveillance in a high drug/crime apartment complex in the City of Burton. Officers observed a drug transaction occur in the parking lot. Officers approached to make contact and one vehicle fled from marked patrol units. The vehicle was attempting to leave the complex and struck an unmarked FANG vehicle. A male was arrested for delivery of marijuana and the female driver was arrested for possession of marijuana and Felony Flee and Elude. She was lodged in the Genesee County Jail.

On 12-17-14, FANG officers conducted a controlled purchase of Cocaine using a Confidential Informant (CI). The CI drove to the house of a known drug dealer in the City of Flint. The CI entered the home and

purchased cocaine from the suspect. FANG officers conducted surveillance and gathered intelligence on the suspect. The investigation is still on going.

On 12-18-14, FANG officers executed a search warrant at a residence in the City of Flint. Three males were located at the home upon entry. Two ran north and were taken into custody after a short foot pursuit. Officers seized 29 grams of "crack", .5 grams of heroin and 4.6 grams of marijuana. Forfeiture was initiated on \$921.00. Two of the males were lodged in the Genesee County Jail. The third male was released pending further investigation.

On 12-22-14, FANG officers conducted a controlled purchase of hydrocodone pills using a Confidential Informant (CI). The CI drove to the house of an unknown drug dealer in the City of Flint. The CI entered the home and purchased the pills from a female subject inside. FANG officers conducted surveillance and gathered intelligence on the suspect. The investigation is still on going.

On 12-29-14, FANG officers conducted surveillance on a male suspect that was said to be in possession of cocaine and a handgun. Officers received information that the male was in route to the south side of Flint to sell the gun and cocaine. FANG officers located the vehicle and conducted surveillance until a traffic stop was initiated with a marked MSP unit. Officers located approximately 1 gram of cocaine and a handgun. The male driver was arrested and lodged on the fresh charges. A female passenger was lodged in the Flint City lock up on outstanding warrants.

On 12-30-14, FANG officers were conducting surveillance on a known drug dealer on the east side of Flint. Officers observed what appeared to be a drug transaction between the suspect and another male. Officers made contact with the suspect as he pulled into his drive. A consent search was done on his home and just over one (1) ounce of "crack" cocaine was located. The investigation is still ongoing.

I would also like to again welcome Gaines Township "Back" to FANG!

The Michigan Public Service Commission (Commission) will hold a public hearing to consider Consumers Energy Company's (Consumers Energy) December 5, 2014 application, which seeks Commission's approval to adjust its existing retail electric rates in three stages to provide net additional revenues of approximately \$163 million annually by May 31, 2016, to implement or modify several cost recovery mechanisms or proposals. Consumers Energy represents that the Company's proposal includes an Investment Recovery Mechanism that includes incremental revenue increases, subject to reconciliation, of \$163 million for 2017 and an additional \$78 million for 2018 above levels reflected in test year rates. Consumers Energy also seeks approval to terminate its current Power Plant Bill Credit associated with the Company's July 2014 securitization financing. Consumers Energy states that factors contributing to the requested increase include: (i) the purchase of a 540 megawatt combined cycle natural gas plant located in Jackson, Michigan; (ii) ongoing investments in electric utility generation and distribution assets to comply with environmental and legal requirements; (iii) ongoing investments in electric utility generation and distribution assets to provide safe and reliable service; (iv) ongoing investments in technology improvements, including investments associated with the Company's Smart Grid (Advanced Metering Infrastructure) project; and (v) increased Operations and Maintenance expenses necessary to improve the reliability of service to customers.

Consumers Energy is also requesting Commission approval to design rates aligned with the requirements of Public Act 169 of 2014 and the Commission's related order. Consumers Energy represents that the Company's proposed rates will result in an annual residential class increase in jurisdictional revenues of approximately 10.5%, an annual secondary class increase of approximately 5.9%, and an annual primary class decrease of approximately 6.5%.
