# **ROUTINE BUSINESS – REVISITED ISSUES / PROJECTS**

# ✓ MICHIGAN TAX TRIBUNAL APPEALS (No Change in Status)

We are proceeding with answering the Kroger appeal. We also have a claim for the medical office building on the east end, commonly known as the VPH Building. This claim was originally a small claim, but since the court found the value to be higher than what our records show it now qualifies for a large claim (how ironic). We have successfully defended a small claim for the apartments on Brady Street.

We will keep the council informed regarding appeals and the need for appraisals as we move into winter.

# ✓ STREETS (See Individual Category)

✓ 2020-2023 TRAFFIC IMPROVEMENT PROGRAM (TIP) (No Change in Status)

Morrish Road is slated for 2022 federal funding. Note that the total scope of the project is around \$1,050,000, with 20% being the city's contribution.

The city has committed the match portion to this project, which is 80-20. It is unclear what year this project will be undertaken, but we want it done subsequent to the USDA water main work. This MAY span two construction seasons. We have put the engineers on notice regarding our desire to widen Paul Fortino to the north so that a left turn lane may be added. This will occur whether or not the townhome project proceeds.

# ✓ QUALIFIED BIDDING SELECTION PROCESS (Update)

We extended the deadline to the end of this week due to a lack of submissions. We have expanded and recast the net. Once tabulated, we will be reviewing these this month, with the intention of having our selection this calendar year.

This process is to ensure the city has a Michigan Department of Transportation pre-qualified engineer to work on projects with federal aid. It is obviously a good practice to apply for non-federal aid projects as well. The selection is valid for up to five years.

# √ STREET PROJECT UPDATES (Update)

This is a standing section of the report on the status of streets as it relates to our dedicated levy, 20 year plan, ongoing projects, state funding, and committee work. Information from previous reports can be found in prior city council packets.

We expect to be able to release bids for 2020 projects soon. The scope includes a section of Oakview, Chelmsford, and Oxford (including the last small stretch of Winston). Note that it is unlikely we will have a budget to do all of those sections in 2020 since state revenues have not been forthcoming as expected. However, it is work that needs to be completed for the USDA watermain on those streets in the next three years.

Notable issues currently include the proposed layout and ownership (school or city) of the bus lane on Oakview by Syring. We will liaise with the school regarding this and how they wish to proceed with the bond improvements.

# ✓ WATER – SEWER ISSUES PENDING (See Individual Category)

# ✓ SEWER REHABILITATION PROGRAM (Update)

The capacity study has been executed and should be underway soon. The Genesee County Drain Commission did verbally commit to reimbursing the city for some of the work related to water and sewer, since they plan to use it from time to time. I do not have a figure at this time, but I expect it to be half of what is related to sanitary sewer and water line mapping.

As it relates to pipe rehabilitation, this multi-year program is on schedule and budget. Based upon current rates and existing fund balance, staff may recommend expending more in the next year or two on the sewer rehabilitation plan in order to get some higher risk assets completed more quickly.

We plan to meet with our sewer rehabilitation expert and engineers the week of the 11<sup>th</sup>.

# ✓ WATER MAIN REPLACEMENT - USDA (Update)

We should be ready to bid this month.

Bond counsel and other team members have been tentatively assembled and await progress. The audit letter has been approved. We finally have terms with the matter of pipe diameter. The USDA will only fund pipe that is thinner than the Genesee County Drain Commission Standards. Previously, The USDA would not budge on funding thicker pipe, and the GCDC would not allow thinner pipe. We finally have approval from the GCDC, provided that the leads include a 'saddle' to compensate for the lack of threads that can be provided for using thinner pipe.

Prior system report findings follow:

The Genesee County Drain Commission - Water and Waste Services Division Water Master Plan, indicates they are considering a northern loop to provide redundancy and stability to the system. This is good news since Gaines and Clayton Township rely on the overstressed Miller line. There is currently not any cost or participation information available. I will keep the council informed.

The city has been working with the county to abandon the Dye Road water main in the vicinity of the rail line. Note that we are holding this action pending the master plan review. This line is prone to breaks, which can be very costly and dangerous near the rail spur. The intention would be to connect our customers to the other side of the street, onto the county line. It appears the transition cost would be about \$25,000. We will work with the county on this matter and report back on our findings.

Lastly, the city should probably complete full demolition on the "Brown Road" site (the old well head) and sell this property. This is not a high priority, but it is now on our radar.

# √ HERITAGE VACANT LOTS (Update)

The last of the lots acquired prior to the special assessment have been approved for sale. The city also has two more lots that were acquired through the tax reversion process. At this point the buyer, JW Morgan, has not executed the transaction. The market for Heritage Village is soft. I will allow these instruments to expire, and we can revisit this matter when circumstances change.

- ✓ NEWSLETTER (No Change of Status)
  - The next newsletter will be the winter quarter. Give me content ideas if you have them.
- ✓ CONSTRUCTION & DEVELOPMENT UPDATE (See Individual Category)
  This will be a standing section of the report that provides a consolidated list for a brief status on public and private construction/developmental projects in the city.
  - 1. **The façade grant is** pending for renovations on 5015 Holland. This project may be altered and pushed into 2020. However, renovations at 7530 Miller are complete, and it is looking good!
  - 2. The city hopes to commence construction on **about \$1 million of grant support recreational path in 2020**. The MDOT grant is conditionally awarded and we await word on the DNR grant portion.
  - 3. *(Update)* The first year of Jeepers Creekers is behind us! We will be debriefing this week, and I should be able to report the good, the bad, and the prospects for the future by the time we meet.
  - 4. (Update) The raceway has been granted tentative 2020 race days. They intend to use the site for thoroughbred horse racing. However, they indicate a need to have some additional legislation related to mobile application betting. They are open to finding additional users for the site to supplement the racing. They are also communicating well in regards to partnering with community groups such as Hometown Days. I find the new owners to be very astute and capable.
  - 5. A Flint based group has a purchase option for **Mary Crapo.** The intent is to use the building and site for senior housing. This would result in new residents in the downtown and the potential for new construction on part of that site.
  - The school bond passed and many improvements are expected in 2019 throughout the district. Total investment for this effort will exceed \$50 million over two to three years. Plans have been submitted for work on Syring and Elms School.
  - 7. **Street repair in 2020** is to include Chelmsford. We also hope to include the remainder of Winston and Oxford Ct. The city also has grants and loans for about **\$5 million in water main work** to occur between 2020 and 2022.

- 8. The **Applecreek Station** development of 48 townhomes is seeking final review by the county. These units range in size from 1,389 to 1,630 square feet, with garages. Construction will occur on vacant land in the back of the development, by Springbrook Colony. Site engineering plans have just been submitted by the owner. Rents are expected to be about \$1.00 per square foot (~ \$1,600 a month) which matches rents in Winchester Village. If this project occurs in 2019, 2020 DDA revenues will be positively and substantially improved.
- 9. The Brewer Condo Project was given site plan approval and tentative purchase agreement approval. This includes 15 townhome condos off Morrish Road in downtown. They are approximately 1,750 square feet, with two car garages and basements. Parking on the raceway property has been tentatively approved by the owner, and we are working on a plan to level and maintain the surface to replace lost parking on Paul Fortino Drive.
- 10. The city council approved the use of state tax incentives and local utility waivers for redevelopment sites in downtown, rounding out our efforts to be a certified Redevelopment Ready Community.
- 11. The **elevator now has a new tenant** that wishes to engage in auctions. Because it is in an industrial district, they should be able to hold limited outdoor sales events with an administrative approval.
- 12. The next **Springbrook East** phase is under construction. Underground work is nearly complete.
- 13. (*Update*) We received the **synthetic tree for Holland Square** that can be used during the Christmas holidays. It will initially be 14' tall, with multi-colored LED's. However, the tree can be expanded in increments of 2' as time goes on!

# ✓ **TRAILS** (No Change of Status)

We re-submitted our application on October 1. Based upon the feedback from the state, we expect to get additional points for environmental benefit, Americans with Disabilities performance standards, and collaboration. I hope to have a positive response regarding this application by December.

Engineering is being completed as we speak. This will ensure that, pending a late award, we will still have time to bid. Bidding early in the year (during the winter months) generally results in better pricing.

The DNR grant is crucial to offset the 35% that the city must cover to match the Enhancement Grant. The MDOT Enhancement Grant is conditionally awarded. We hope this covers 65% of the investment. Work with Consumers Energy and CN Rail is positive for those project components that require their engagement. We are still working with the MTA and GM on some easements and permissions.

Note that the city will still be heavily invested in this, even if both grants are awarded. Count on a general fund outlay of \$200,000 for the local match and additional engineering, construction, and inspection services. Any overages (price changes and change orders) will be locally covered as well.

The project timeline will be revised. At its core, it should still reflect a 2020 construction timeframe. The difference is that we plan to engineer the project sooner than anticipated so we can bid it upon a conditional DNR award in a year's time.

# ✓ REDEVELOPMENT READY COMMUNITIES (Update)

The formal recognition for the RRC program will be at the city council meeting on December 23rd.

# ✓ DURAND AREA INDUSTRY - PROJECT TIM (Update)

This project seems cold and quiet. In fact, American Steel is showing losses with domestic steel production so this industry is not showing signs of strength. However, it appears there are still valid purchase agreements in place for the development, and there are state and local bureaucrats continuing work on contingency plans for utility and traffic planning. It is anyone's guess at this point. Please see prior packets for information on the project and its evolution. At this point, I will look to remove this from future reports until something relevant shows itself.

### ✓ TAX REVERTED PROPERTY USE (No Change of Status)

I am seeking release from the buyers of tax reverted property on Wade Street and Heritage. I am doing so because the council granted sale approval over one year ago, but the purchase agreements remain unsigned after numerous requests. We can look to reoffer the properties or allow time to mature the prospects more.

# ✓ 8002 MILLER (Update)

The contractor is working more earnestly on the first floor. Occupancy of the upstairs apartment has been finalized, and the updated lease has been executed. We are looking to expedite improvements on the first floor so the business can function normally.

Note that the proceeds from this lease MUST go to offset the cities investment, effectively counting towards the eventual sale price by the user. This closely resembles a land contract. In fact, the city attorney may recommend we proceed directly to a land contract at this point as a means to recognize the current lease and eventually purchase terms.

#### ✓ **SCHOOL FACILITY PROPOSAL** (No Change of Status)

It is expected that elementary security entrances and related work will be the first phase of the investment. There are plans in for Syring, with the expectation that this work will commence in 2019.

The school has placed a construction trailer to oversee this massive set of projects. This is located near the administration building, but away from work efforts, on the property next to the bus garage. Though this is obviously temporary, the project could take a couple years.

Additional bond work shall continue in 2020 and 2021. It will include all facilities, including athletic facilities at the high school. We expect cooperation and benefit in terms of establishing safer connections for walkers, better land grades (e.g. the football field), and more attractive gateways.

# ✓ BREWER TOWNHOMES (No Change of Status)

The site plan and sale has been approved. We await transfer of the property pending final approval of the condominium documents by the city attorney. The builder is also still working on final drainage plans with Genesee County. It appears some additional underground investment may be needed. As previously noted, this development is a candidate for water and sewer fee waiver incentives. I will have more information soon.

# ✓ SPORTS CREEK RACEWAY & GAMING COMMISSION (Update)

The raceway has been granted tentative 2020 race days. They intend to use the site for thoroughbred horse racing. However, they indicate a need to have some additional legislation related to mobile application betting. They are open to finding additional users for the site to supplement the racing. They are also communicating well in regards to partnering with community groups such as Hometown Days. I find the new owners to be very astute and capable.

# ✓ **CDBG** (No Change of Status)

At this point, we are looking to upgrade street name/stop signs in the downtown area using these funds. Improvements should be eligible for funding in the fall of 2020.

# ✓ **SAFE ROUTES TO SCHOOL** (No Change of Status)

The application has been submitted. We are proceeding with the understanding that preliminary engineering, accurate pricing, and a final construction plan have not been settled. As we proceed with a potential award, we will have the opportunity to prioritize and select various project components, with the understanding that we will only need to proceed if funding is allocated through the grant.

As of writing, the school has been fantastic to work with. They indicate a willingness and ability to supply many of the desired improvements as they proceed with bond upgrades, including walkways and a potential pedestrian bridge.

# ✓ CENSUS COMPLETE COUNT COMMITTEE (No Change of Status)

The committee met on October 1<sup>st</sup>. They plan to reach out to the Swartz Creek schools for Honor Society students that can acquire volunteer credit for their work with social media to educate the community in the Census 2020. They also plan to have a table at events throughout Jeepers Creekers, educating the community about the importance of the census. The slogan is "Be Counted For 2020 Census". They had a jar full of coffee beans for people to guess at the count and a chance to win a prize from Fireside.

The Complete Count Committee consists of Angie Root, Mary Ann McCarthy, and Chairman Dennis Cramer. They are also working on promotional materials.

### ✓ **GIS MAPS** (No Change of Status)

We will be working with Rowe to complete map and database creation. We will also seek a partial reimbursement from the Genesee County Drain Commission. Please see the report in the August 12 City Council packet for full details.

# ✓ DISTRACTED DRIVING (Business Item)

The ordinance was approved at the October 28 city council meeting. This will be removed from future reports.

# ✓ LOCAL OFFICERS COMPENSATION COMMITTEE (Update)

The compensation commission met on October 24<sup>th</sup> at 5pm. Prior to this year, the last time they met and adjusted compensation was fall of 2017. They made adjustments to city council member and mayor compensation by converting the city-provided technology and service program to an initial stipend of \$1,000 and increasing the meeting stipend by \$10 for ongoing/replacement technology. This amount replaces the city-provided laptop and ongoing service. Councilmembers will receive this when they turn in their laptops. Replacement of the laptops (or similar technology sufficient to conduct business) now and in the future will be the responsibility of council members/mayor.

Councilmember and mayoral stipends were also increased by \$10 per meeting for costof-living purposes. The mayoral annual stipend, paid monthly, was increased by \$25 for the purpose of covering non-reimbursable costs related to public appearances and official duties assigned that office. There is also an additional \$5 per meeting for the Mayor (this increase was not reflected in the last report but reflects the deliberation and resolution of the LOCC as approved in the minutes and voice recorded).

Council member annual stipends did not change. The proposed compensation follows:

Mayor: \$90 per meeting (\$65 previously)
Council Member: \$85 per meeting (\$65 previously)
Mayor: \$1,200 per year (\$900 previously)
Council Member: \$600 per year (\$600 previously)

Mayor: \$1,000 initial stipend (city-provided previously)
Council Member: \$1,000 initial stipend (city-provided previously)

Minutes were approved on November 7 and filed with the clerk on the 8<sup>th</sup>. This compensation will be effective in December 8<sup>th</sup> unless overruled by the city council.

✓ SHARED SERVICES AGREEMENT-MUNDY TOWNSHIP (No Change of Status)

Mundy's park will not be completed this year. As such, any need for services is put on hold as it relates to utilizing our labor and maintenance staff/equipment. The previous report follows:

Mundy Township is very interested in utilizing our existing labor and equipment resources to support their new park facility on Hill Road. We have come to verbal terms with each other regarding expectations. I have also ensured we have the capacity and willingness from the DPW Director and union steward that represents the crew that will be doing the work. The city Treasurer is also equipped to track, report, and invoice such services by virtue of extending a system of accounting that we use to enable our staff to maintain the park and ride.

Moving forward, I expect to deliver a short shared services agreement that will enable city labor and equipment to be used to maintain the Mundy Township park. Again, this agreement will resemble the MDOT park-and-ride service expectation, while taking the form of the shared service agreement we have with Mundy Township for building services. Conceptually, I think this is a great idea to create efficiency for the township and more capacity for the city, while ensuring costs are fairly and appropriately covered. The working plan appears to support the concept in terms of its functionality and demand on our resources.

# ✓ JEEPERS CREEKERS EVENT (Update)

With this event concluded, I will remove this from future reports.

# ✓ **DISC GOLF** (No Change of Status)

Disc Golf is proposed for the Bristol Road property (let's call it Bristol Fields until something better comes along). A park board committee has been formed to create a physical, financial, and implementation plan to make this happen. We are looking to locate corner stakes before planning the site.

# ✓ DIRECTOR OF COMMUNITY SERVICES SUCCESSION PLAN (Update)

The city approved shared service agreement with Mundy. If Mundy approves it as well, we are good to go with employing and compensating a professional engineer.

In the meantime, I am working with Tom to document and record various features and functions of the job to ensure a legacy plan for the position. I expect to have someone on the job in early January. The likelihood of having overlap is very small.

#### The previous report follows:

Tom Svrcek has submitted his notice of retirement, effective on January 3, 2020. Tom has been with the city for over twenty years and has made his mark on all of our current initiatives, from the street program to the downtown flowers. He has brought a fantastic and practical skill set here with him that will be sorely missed. He has also provided a genuine and very human presence within our Department of Public Works that cannot be replaced. We will miss you Tom! But he isn't gone yet, so we better bug him about what he knows ©

I will be working diligently to ensure a smooth transition as we move forward with a new director. Based upon the ridged regulatory environment around public utilities as well as the massive needs we have with the USDA water main project, recreational investments, and street program, I am inclined to pursue the hiring of a professional engineer that possess administrative and regulatory skills.

Such a position will come at a great financial cost. However, having a certified professional engineer will also ensure that our projects are being overseen with a high degree of scrutiny towards efficient processes, proper methods/materials, optimal design, safe conduct, etc. I expect this position to result in direct savings for SOME services that are currently billed hourly or contracted through our third party engineers (e.g. hourly services for drainage troubleshooting in Winchester Woods). I also expect to ensure proper outcomes for the \$10,000,000 worth of water main, sewer investment,

streets, and trails that we expect in the next five years. Even so, this is a tall order for a community our size.

# ✓ MUNICIPAL SURVEY (Update)

The Center for Local, State, and Urban Policy has released their findings regarding the assessments of local government leaders regarding views on the next recession. The findings are there for review. I personally take a more negative view.

I find that the last few years have been the best in decades concerning local economic growth and state tax revenue growth. The result has been inflationary increases. The last recession cut our revenues by about 40%. As such, if great years result in "getting by", a recession could be devastating. This is especially true since we have already consolidated fire, police, building, and tentatively engineering services. We have also cut staff and greatly increased taxes and assessments.

Most municipalities are in the same boat or worse, especially when considering debt, which we are well positioned on. Frankly, I don't see how local and county governments can weather another recession with state level tax reform, which is something I hope council members can learn about in the next year by attending Michigan Municipal League conferences/conventions.

# ✓ BOARDS & COMMISSIONS (See Individual Category)

# ✓ PLANNING COMMISSION (Update)

There is no business for the planning commission in November so we will postpone the meeting indefinitely. This is a rare occurrence this year. The next meeting is scheduled for December 3rd. We are expecting to meet in December and hold a training that all city officials are encouraged to attend.

#### ✓ **DOWNTOWN DEVELOPMENT AUTHORITY** (No Change of Status)

The DDA could not meet on October 10<sup>th</sup> due to a lack of member availability. They are scheduled to meet on November 14<sup>th</sup> and I expect them to proceed with the purchase of an inflatable screen and new projector. The idea had a lot of traction from the DDA Board and the Firemen's Association, which is engaged in running Family Movie Night. There is belief that an inflatable screen can replace the deteriorating permanent screen at Pajtas and also offer more location and user flexibility.

# ✓ ZONING BOARD OF APPEALS (Update)

The ZBA met on October 16th to continue consideration of a use variance that would enable a non-residential use on a residential parcel. The petition requested permitting to perform land grading with the addition of substantial fill on the vacant land located on Seymour Road by the creek. The initial hearing was held on August 21st.

There was much public participation and deliberation at both meetings. The ZBA was not able to make findings in August due to a lack of information regarding the expected impact on the creek flow and potential for flooding. There were also concerns about the final appearance of the fill area. New information was provided that alleviated concerns regarding flood plain impact. Concerns were still prevalent concerning the hill height and appearance.

Ultimately, the petition was approved with limitations and conditions. This results in less fill being added and a restoration bond being required, among other conditions. Draft minutes are included.

The ZBA will reconvene on November 20<sup>th</sup> to affirm the minutes.

### ✓ PARKS AND RECREATION COMMISSION (Update)

The Park Board met on November 6th. The board discussed trunk or treat. A canopy is requested for next year. The fire department folks discussed the Christmas Parade. They may be looking to do a pre-parade event at Holland Square. There are not any details at this time.

Christmas decorating judges will be Connie, Samantha, Jentery, and Trudy.

A committee of Mr. Farmer & Mr. Barclay, along with the local disc golf folks, is still working on a design plan and budget for the disc golf area on Bristol Road. A survey is pending.

The next meeting will be on December 4th at city hall.

# √ BOARD OF REVIEW (Update)

# **NEW BUSINESS / PROJECTED ISSUES & PROJECTS**

# √ OTHER POST EMPLOYEMENT BENEFIT ACTUARIAL (Business Item)

Staff is requesting the approval of an agreement and allocation of funds for the purpose of auditing the city's Other Post-Employment Benefits. This will be the third time we have done so as required by recent GASB accounting standards within the State of Michigan.

What does this mean in plain English? We are seeking assistance to formally report what liabilities exist for retiree health care and how much we should be setting aside each year to pay for it.

Currently, the city uses the pay-as-you-go method to cover such benefits, meaning that when someone retires we pay a share of their medical premiums or cover a nominal cost of their health care expenses as required by the applicable labor agreement. These costs are built into our annual operating budget. (Note that our current bargaining agreements provide for post-retirement medical as a contribution to a health savings program in the form of a percentage of wages, meaning that current and new hires will not accrue liabilities moving forward.)

The Governmental Accounting Standards Board is requiring that communities track existing liabilities and/or annual contributions in a manner similar to how pensions are valued and accrued. In essence, the standards are going to require that communities show their unfunded accrued liabilities in the same manner for post-employment medical benefits in a similar manner to unfunded accrued liabilities for pensions.

To accomplish this, Deanna has solicited a proposal from a highly recommended firm. I have included the proposal and service agreement in the packet. There is a lot of technical jargon in there, but they are able to give us the valuations expected for \$7,250 for fiscal year 2020, with \$2,000 subsequent updates for two years. I have included a resolution to get us moving.

# ✓ CHRISTMAS PARADE (Business Item)

Included with tonight's program is a request from the Swartz Creek Area Fire Fighters Association to conduct the annual Christmas Parade. This year's event has been scheduled for Saturday December 7, 2019 at 6:00 PM. The starting point is now the Middle School instead of the Performing Arts Center. The route then follows Miller east to Morrish Road, and back west to Fortino. This route was started a few years back in order to engage the downtown businesses. It is workable but definitely more stressful to traffic. Given the desire to expand Christmas offerings in town, it is doable.

A gathering follows at the fire hall at 8100 Civic Drive. This route will allow traffic diverted into Winchester Village at Winston to circumvent the parade at Fairchild and Ingalls to continue east.

# ✓ ROAD SALT PRICE AWARD (Business Item)

Genesee County, with whom we have a cooperative purchasing agreement, has negotiated another contract with the Detroit Salt Company for the procurement of road salt for the next season. The price will increase from the current to \$54.40 per ton to \$59.07 per ton. This is an increase of about 8.5%. While this is a departure from the stable prices of the last couple years, it is in line with the 2016 price of about \$59, and well below the spike from four years ago when non-contract communities saw temporary prices around \$100/ton.

The reason we choose to piggy-back with the county is because of their purchasing power. The cooperative bid includes nine different entities that use approximately 100,000 tons of salt each year collectively. Our city uses about 1,100 tons a year, and there is no practical way we could bid or negotiate such a deal on our own. A resolution is included that enables this purchase as a cooperative purchase.

# Council Questions, Inquiries, Requests, Comments, and Notes

Small Cities: It looks like the city will host in January. I will have more information soon.

Lutheran Church: I have received information from our assessor in response to the petitioners from the church that had questions about their exemption at the October 28 city council meeting. The opinion of the State Tax Commission is that ownership must be exclusive for the exemption to apply. This can be applied locally at the Board of Review in March and subsequently to the State Tax Tribunal. Their response is included in the packet.

Republic Waste: We have noticed some collection vehicles are discharging oil on the roadways. We have notified the company that this is unacceptable due to the impact on the environment and the integrity of the asphalt streets.

# A RESOLUTION TO AMEND SECTION 18 OF THE CODE OF ORDINANCES BY ADDING SECTION 18, ARTICLE 5 DISTRACTED DRIVING

**WHEREAS**, the City of Swartz Creek maintains police power over the operation of motor vehicles; and

**WHEREAS**, the prevalence of distracted driving and the accidents and injuries resulting from such behavior is pronounced in Genesee County, Michigan.

NOW, THEREFORE, I MOVE the City of Swartz Creek ordains:

#### CITY OF SWARTZ CREEK ORDINANCE NO. 445

An ordinance to amend Chapter 18 of the Code of Ordinances by adding Section 18, Article 5, entitled "Distracted Driving."

#### THE CITY OF SWARTZ CREEK ORDAINS:

### Section 1. Amendment of Chapter 18 of the Code of Ordinances.

The City hereby amends Chapter 18 of the Code of Ordinances of the City of Swartz Creek by adding Section 18, Article 5, entitled "Distracted Driving" to read as follows:

Sec. 18-101. - Title.

This ordinance shall be known and cited as the Swartz Creek Distracted Driving Ordinance.

#### Sec. 18-102. - Definition.

### "Distracted Driving" means the following:

- 1. The physical manipulation of any 2-way wireless electronic communication device used for dialing numbers; or scrolling; or typing or entering multiple letters, numbers, symbols, or other text; or the sending, receiving, and reading of any non-voice data in the device while the motor vehicle is in motion on any highway or street or place open to the general public within the City of Swartz Creek. As used in this subsection, a wireless 2-way communication device does not include a global positioning or navigation system that is affixed to the motor vehicle.
- The physical manipulation or handling of any wireless entertainment or electronic communication device for the purpose of speaking into, or listening to voice data, while the motor vehicle is in motion on any highway or street or place open to the general public within the City of Swartz Creek; or
- 3. Any action by the driver of a motor vehicle that diverts his or her attention resulting in the failure to use due care and caution in the safe operation of a motor vehicle while the vehicle is in motion on any highway or street or place open to the general public within the City of Swartz Creek. Such action can include but is not limited to: eating, reading, writing, performing personal hygiene/ grooming, physical interaction with pets, passengers, or unsecured cargo, any of which is done in a manner that prohibits the driver from

maintaining direct physical control of the motor vehicle steering mechanism with at least one hand that is free of all other objects and used entirely to form a controlled grip on the steering mechanism.

#### 4-53. – Violation as a Civil Infraction.

- 1 A person shall not engage in distracted driving within the City of Swartz Creek.
- 2 A person who violates this section is responsible for a civil infraction.
- 3 Exceptions. This section does not apply to a person who is using an electronic communication device to do one or more of the following:
  - a. Report a traffic accident, medical emergency or serious road hazard.
  - b. Report a situation in which the person believes his or her personal safety is in jeopardy.
  - c. Report or avert the perpetration or potential perpetration of a criminal act against the individual or another person.
  - d. Carry out official duties as a police officer, law enforcement official, member of a paid or volunteer fire department, or operator of an emergency vehicle.

#### Section 2. Effective date.

This Ordinance shall take effect twenty (20) days following publication.

#### October 2019

- **10/02** FANG detectives conducted an undercover purchase of heroin from a dealer in the Flint area. The dealer was identified, and the investigation is ongoing.
- **10/03** FANG detectives utilized a confidential informant to conduct a controlled purchase of crystal meth. The dealer has been identified and the investigation is ongoing.
- **10/04** FANG detectives conducted a search warrant on a BHO lab in Flushing Township. During the execution of the search warrant FANG detectives seized 3 guns, several pounds of processed marijuana, to include several pounds of edibles and waxes. FANG dismantled an illegal marijuana grow operation that had over 250 plants. As a result of the search warrant over \$150,000 in cash and assets were seized for forfeiture.
- **10/07** FANG detectives flagged an address suspected of receiving narcotics through the mail. U.S. Postal agents intercepted a package containing ½ kilo of crystal meth headed to the flagged location by FANG. A controlled delivery was conducted, and two suspects were arrested.
- **10/08** FANG detectives utilized a confidential informant to purchase heroin from a known dealer in the Flint area. The investigation is ongoing.
- **10/09** FANG detectives utilized a confidential informant to purchase heroin from a dealer in the Flint area. The investigation is ongoing.

# Michigan local officials' views on the next recession: timing, concerns, and actions taken

This report presents the assessments of Michigan's local government leaders regarding the next recession, including its expected timing and impacts, and whether their jurisdictions have taken action to prepare for it. These findings are based on statewide surveys of local government leaders in the Spring 2019 wave of the Michigan Public Policy Survey (MPPS).

>> The Michigan Public Policy Survey (MPPS) is a census survey of all 1,856 general purpose local governments in Michigan conducted by the Center for Local, State, and Urban Policy (CLOSUP) at the University of Michigan in partnership with the Michigan Municipal League, Michigan Townships Association, and Michigan Association of Counties. The MPPS investigates local officials' opinions and perspectives on a variety of important public policy issues. Respondents for the Spring 2019 wave of the MPPS include county administrators, board chairs, and clerks; city mayors, managers, and clerks; village presidents, managers, and clerks; and township supervisors, managers, and clerks from 1,364 jurisdictions across the state.

#### **Key Findings**

- A majority of local leaders statewide (57%) are concerned about the potential impact of the next recession on their jurisdictions' ability to deliver public services and maintain government operations.
  - » More than three-quarters of officials from larger communities (with more than 10,000 residents) are concerned about the potential impacts on service provision.
- Although many local officials are concerned about the next recession, there is little immediate sense of urgency. Overall, 39% of local leaders don't know when to expect the next recession will start (when asked in spring 2019), while 57% believe it is more than a year away, including 31% who say it is more than two years away. Meanwhile, just 3% think it will likely start within the next 12 months.
- Only 13% of local leaders believe their jurisdictions are very prepared for the next recession, although another 57% say they are at least somewhat prepared. Meanwhile, 20% report being either somewhat unprepared (16%) or very unprepared (4%) to deal with the next economic recession.
  - » Local officials who say their jurisdictions are unprepared for the next recession are most likely to be from mid-sized jurisdictions and those in the Upper Peninsula, Southeast, and East Central regions. In addition, county officials are more likely than city, village, or township officials to say their jurisdictions are unprepared.
- Finally, just a quarter (26%) of local officials report their governments have taken specific actions to prepare for the next economic recession, although this includes over half (55%) of the state's largest jurisdictions (those with more than 30,000 residents).

#### **Background**

Talk about the next recession has been increasing over the past year among economists looking both at the nation as a whole¹ as well as those focusing on Michigan in particular.² Michigan may be on the leading edge when the next recession hits, with one recent forecast identifying Michigan as the state with the highest risk of suffering recession in the near term.³ Michigan's business leaders are also expressing heightened concerns, with nearly half (46.5%) in a recent survey predicting a downturn in the state economy in the next six to twelve months, a significant increase over earlier this year.⁴ However, pinpointing exactly when the next economic downturn will hit is always a challenge. Although some suggest a recession may have already begun,⁵ or predict it will begin by the end of next year,⁶ no one can be sure exactly when it will occur or how bad it might be. In fact, others such as Jerome Powell, chair of the Federal Reserve Board, argue that currently the national economy is strong and risk of recession is relatively low.² Furthermore, the University of Michigan's Research Seminar on Quantitative Economics (RSQE) which provides forecasts of both the U.S. national economy and the Michigan economy does not currently predict a major downturn for Michigan in the near term."8

Statewide, Michigan has experienced 10 years of steady economic improvement since the end of the Great Recession in 2009. But despite the state's overall recovery, there are reasons to believe it may be particularly vulnerable to the pain inflicted by a potential new economic recession. Even in recovery, Michigan's trends in traditional economic indicators have been mixed. For example, *Crain's Detroit Business* reported last year that while the state's GDP per capita is up, at the same time household income is down, and while unemployment has improved, fewer Michiganders are actually working compared with levels before the Great Recession. Recession.

The state government's ability to handle an economic downturn may be uncertain as well. George Mason University researchers analyzed states' general and rainy day fund balances and found that Michigan may be ready to weather a mild recession, but not necessarily an extreme or even average one.<sup>11</sup> And at the local level, not every Michigan community has shared in the economic improvements over the past decade, with many local governments reporting persistent fiscal stress.<sup>12</sup>

To get a sense of whether local leaders believe their government is prepared for the next recession—whenever it may arrive—the Spring 2019 MPPS asked local officials when they think the next recession will begin, whether they are concerned about its potential impacts on government operations and service provision, how prepared they feel for it, and what preparatory actions, if any, they've taken.



# A majority of jurisdictions statewide are concerned about the next recession's potential impact on service delivery and government operations

Officials in more than half of Michigan's local jurisdictions are concerned about the potential impact of the next economic downturn on their government's ability to provide services (58%) and on their government's own operations (57%). When it comes to the quality and/or amount of services provided by their government, 12% of local leaders are very concerned about the impact of the next recession, and another 46% are somewhat concerned (see *Figure 1a*). Local leaders are also anxious about the potential impacts of a new recession on their general government operations, with 15% indicating they are very concerned and another 42% somewhat concerned.

Apprehension over how local governments and the services they provide might be affected by the next recession are particularly widespread among larger jurisdictions. This is understandable, since the larger the local government, the more likely it is to offer extensive services. In addition, prior MPPS research in the wake of the Great Recession found that fiscal health did indeed fall faster and farther among the state's larger jurisdictions, compared with smaller ones.<sup>13</sup> As shown in Figure 1b, more than a quarter (26%) of officials from the state's largest jurisdictions—those with more than 30,000 residents say they are very concerned and another 54% are somewhat concerned about potential impacts from the next recession. But that's not to say that small communities are not worried. Even among leaders from the state's smallest jurisdictions—those with fewer than 1,500 residents—around half express concerns about potential negative impacts from the next recession on service delivery.

When looking regionally, local officials from Southeast Michigan are the most likely to say they are very (20%) or somewhat (48%) concerned about potential impacts of a future recession on their ability to provide public services (see *Figure Ic*). By comparison, those from the Northern Lower Peninsula are the least likely to say the same.

Percentage of local officials concerned about impacts of the next recession



Percentage of local officials concerned about impacts of the next recession on government services, by population size




# Most local officials are uncertain about the start of the next recession, but few see it as imminent

Although local leaders have widespread concerns about the potential impacts of the next recession on public services and their government operations, relatively few expect the next recession will hit soon. Based on responses from April-June 2019, only 3% predict the next recession will mostly likely start within the next 12 months (see *Figure 2a*). Another 26% predict it will happen within one to two years, while 31% estimate it is more than two years away. Meanwhile, the largest segment (39%) of local officials simply don't know when they think it will arrive.

Officials from smaller jurisdictions are the least likely to have particular beliefs about when the next recession will begin, with almost half (47%) from jurisdictions under 1,500 residents saying they "don't know" (see *Figure 2b*). By contrast, most local leaders from larger jurisdictions do express views on its expected arrival, and among them only a small number believe a recession is on the near-term horizon. However, in larger communities with more than 10,000 residents, 45%-47% of local leaders believe there will be a new recession in under two years.

Local officials' predictions of how soon the next recession will start




### A majority of local leaders believe their jurisdictions are at least somewhat prepared for the next recession





Figure 3e Local officials' assessments of how prepared their jurisdiction is for the next recession, by self-assessments of current fiscal stress

Despite concerns about the potential impact of the next recession on public services and government operations, most local leaders believe their jurisdictions are at least somewhat prepared to deal with the impacts. When asked how prepared their jurisdiction's government is today to deal with the next recession, 57% say they are somewhat prepared and another 13% say they are very prepared (see *Figure 3a*). Conversely, one in five (20%) local leaders believe that their jurisdictions are either very (4%) or somewhat (16%) unprepared. Another 10% are unsure.

Looking by jurisdiction size, officials from the state's largest jurisdictions are the most likely to believe their governments are either very (15%) or somewhat prepared (64%) for the next recession (see *Figure 3b*). By contrast, medium-sized jurisdictions with between 10,001-30,000 residents are the most likely to report they are unprepared, with almost a quarter (23%) reporting they are very (3%) or somewhat (20%) unprepared.

As shown in *Figure 3c*, by region, local leaders from jurisdictions in the Upper Peninsula are the most likely to say they are unprepared for the next recession (25%), followed by those in the Southeast (23%) and East Central (23%) regions. However, the Southeast is also the region that reports the most jurisdictions that feel very prepared (16%).

the next recession





By jurisdiction type, almost a third of local leaders from counties (32%) and over a quarter of those from villages (28%) and cities (27%) feel their governments are currently unprepared for the next recession (see *Figure 3d*). Meanwhile, township officials are twice as likely (16%) as leaders from other jurisdiction types to say they are very prepared for the next economic downturn.

Each year, the MPPS asks local leaders to rate their jurisdictions' overall fiscal stress on a 1-10 scale. Jurisdictions are then sorted into low (1-4), medium (5-6), and high stress (7-10) categories. Among those jurisdictions in the low stress category, the vast majority say they are very (19%) or somewhat (61%) prepared, while only 12% report they are unprepared for the next recession (see *Figure 3e*). Not surprisingly, those with high stress today are among the most likely to say they are unprepared for the next recession. But even among those jurisdictions that report the highest levels of current fiscal stress, nearly a majority (48%) believe that their jurisdiction is very or somewhat prepared, and only 12% say they are very unprepared.

the next recession, by jurisdiction type

# Just over a quarter of local governments report taking specific actions to prepare for recession

Perhaps due to the relative lack of concern that the next recession will arrive any time soon and because many feel relatively prepared already, few local leaders report specific actions being taken to prepare for the next economic recession. Just over a quarter (26%) of local leaders indicate their jurisdictions have taken any specific actions to prepare, while 62% say they have not, and 12% are unsure (see *Figure 4a*).

It is not surprising that officials from the state's largest jurisdictions are the most likely to feel that their governments are either very or somewhat prepared for the next recession, because they are also the most likely to report having taken specific actions to get ready. Among officials from communities with more than 30,000 residents, 55% report their governments have taken specific actions to prepare for the next downturn (see *Figure 4b*). In addition, half (50%) of officials from jurisdictions with populations between 10,001-30,000 residents also say they are taking steps to prepare, while the same is true among only 16% of those from the state's smallest jurisdictions.

Looking by region, officials from Southeast Michigan (41%) are by far the most likely to report their local governments are taking action to prepare for the next recession (see *Figure 4c*). By contrast, just 17% of leaders from the Northern Lower Peninsula region say they've taken some specific action.

Meanwhile, despite jurisdictions in high fiscal stress feeling much less prepared for the next recession, there are essentially no differences in the percentages taking action among jurisdictions reporting low fiscal stress (28%), medium stress (24%), and high stress (25%). It may be that these places under high stress today simply have too many immediate and costly priorities to deal with, and simply don't have the time or capacity to prepare for something further down the road.

Percentage of local jurisdictions that have taken specific actions to prepare for the next economic recession



Percentage of local jurisdictions that have taken specific actions to prepare for the next economic recession, by population size




Finally, the MPPS also asked local leaders to share specific examples of actions they have taken to prepare for the next recession through an open-ended question. From among the 26% of jurisdictions that indicate they have taken specific actions, over 230 local officials offered examples of policies or practices they are putting in place to prepare. Many highlight efforts that include:

- paying down debt, including making extra payments toward pension and OPEB obligations
- increasing the margin on the overall General Fund balance
- establishing reserve/sinking/"rainy-day" funds (particularly for large future infrastructure needs)
- taking advantage of State of Michigan and private grant opportunities
- being more conservative with spending than in the past

## Quotes from local leaders regarding actions their jurisdictions are taking to prepare for the next recession

"We have been updating our infrastructure on a yearly basis with a goal of having a longer life span for our roads. We have been maintaining a 'future investment' fund so that we are using the previous year's savings to fund those projects."

"We have not restored employees from the first recession. Reworked health care and pension funds with unions. Stopped providing certain services."

"As a response to the Great Recession we created a hybrid public-private system of delivering services for the Building, Engineering and Planning Departments. If service needs decrease, then we have less consultant activity."

"Maintaining a higher level of Unassigned Fund Balance than policy requires. Maintaining additional funding in our budget stabilization fund. Proposing a fiscally responsible 5-year budget. Development of a strategic plan that focuses our efforts."

"Negotiated union contracts to remove healthcare for new hires and shifted to a health savings plan. Paid [substantial] unfunded liability off for the Police Departments MERS. Implemented cost-sharing premiums for all personnel related to healthcare. Established a threshold for unreserved fund balance at 50% of expenditures. Established Capital Improvement Plans for major expenditures. Bridged the Police Departments MERS benefits from a [higher] multiplier to [a lower one]; raised minimum retirement age ..."

"Our Board has been proactive with our Sewer system, Road program, Park system and is working on a CIP for all Township infrastructure. Over the past four years the Board has been reviewing options for Legacy cost and have made some changes to our Employee and Retiree Health and Retirement Plans."

"We are looking at longer term budgeting, also alternative ways to fund large expenditures, i.e., grants, special millage, etc."

"Our township has prepared for projects by saving in special bank accounts for special infrastructure improvements in the future. We do not want to incur debt and could use those funds by resolution in case of a slowing economy. Cash is our motto."



#### **Conclusion**

Although most of Michigan's local governments report slow but steady improvement in fiscal health over the decade since the Great Recession, many local leaders express concerns about weathering the next recession, whenever it arrives. In fact, a majority statewide (57%) are somewhat or very concerned about their jurisdiction's ability to maintain quality services and government operations during the next recession. Furthermore, one in five (20%) report being either somewhat unprepared (16%) or very unprepared (4%) to deal with the next economic recession.

Some local leaders may be uncertain about whether planning for the next recession should be a priority for their local government. When asked for their best guess about when the next recession will hit, 39% of local leaders could not predict, while 57% believe it is more than a year away, including 31% who believe it is more than two years away. Meanwhile, just 3% of local leaders say the next recession will likely start within the next 12 months.

This lack of current urgency is also reflected by reports from local officials that only a quarter (26%) of their governments have already taken specific actions to prepare for the next economic recession. It's important to note, however, that this includes over half (55%) of the state's largest jurisdictions.

#### **Survey Background and Methodology**

The MPPS is an ongoing survey program, interviewing the leaders of Michigan's 1,856 units of general purpose local government. Surveys are conducted each spring (and prior to 2018, were also conducted each fall). The program has covered a wide range of policy topics, and includes longitudinal tracking data on "core" fiscal, budgetary, and operational policies designed to build-up a multi-year time-series.

In the Spring 2019 iteration, surveys were sent by the Center for Local, State, and Urban Policy (CLOSUP) via the internet and hardcopy to top elected and appointed officials (including county administrators and board chairs; city mayors and managers; village presidents, clerks, and managers; and township supervisors, clerks, and managers) from all 83 counties, 280 cities, 253 villages, and 1,240 townships in the state of Michigan.

The Spring 2019 wave was conducted from April 8 – June 10, 2019. A total of 1,364 jurisdictions in the Spring 2019 wave returned valid surveys (68 counties, 225 cities, 186 villages, and 885 townships), resulting in a 73% response rate by unit. The margin of error for the survey for the survey as a whole is +/- 1.37%. The key relationships discussed in the above report are statistically significant at the p<.05 level or below, unless otherwise specified. Missing responses are not included in the tabulations, unless otherwise specified. Some report figures may not add to 100% due to rounding within response categories. Quantitative data are weighted to account for non-response. "Voices Across Michigan" verbatim responses, when included, may have been edited for clarity and brevity. ## SUBSTITUTE FOR HOUSE BILL NO. 4916

A bill to create the lawful sports betting act; to require licensing of persons to engage in sports betting via the internet, including through mobile applications; to impose requirements for such sports betting; to impose tax and other payment obligations on the conduct of licensed sports betting; to create the internet sports betting fund; to prohibit certain acts in relation to sports betting and to prescribe penalties for those violations; to require the promulgation of rules; and to provide remedies.

#### THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the

- (r) "Internet sports betting" means operating, conducting, oroffering for play sports betting through the internet.
- 7 (s) "Internet sports betting account" means an electronic
  8 ledger in which all of the following types of transactions relative
  9 to an authorized participant are recorded:

- 11 (ii) Withdrawals.

- (iv) Monetary value of winnings.

## TERMS OF AGREEMENT

- 1. <u>Services Provided by CBIZ</u>. CBIZ will perform one or more of the services selected by Employer and pursuant to the services outlined on Addendum A, attached hereto and made a part hereof. The specific services to be performed for Employer shall be determined by CBIZ and Employer and may be modified from time to time as agreed upon between the parties.
- 2. Relationship of the Parties. It is understood and agreed that this Agreement does not create any employer/employee, partner or joint venturer relationship between the parties. The parties agree that the relationship between CBIZ and Employer shall be that of independent contractors. As an independent contractor, CBIZ shall have the right to determine the means and methods to be used in accomplishing and providing the services to be rendered hereunder, including but not limited to outsourcing one or more services contemplated herein. Each party shall be responsible for all expenses involved in the execution of any services to be performed by them hereunder and shall also be responsible for all federal, state and local taxes that may be required to be paid by either party. The parties shall not have any express or implied rights or authority to assume or create any obligation or responsibility on behalf of or in the name of the other, except as may otherwise be set forth in this Agreement.
- 3. Requests of Information. Employer acknowledges the importance of providing complete and accurate information to CBIZ prior to the effective date of any and all services provided hereunder. CBIZ, from time to time, will request certain information from Employer, which is necessary to enable CBIZ to adequately perform its duties hereunder. Employer shall, within fifteen (15) days of the mailing or hand delivery of such request, furnish CBIZ with all information requested. CBIZ, its officers, employees and agents shall not be liable for any damages, taxes, interest, penalties, or fines incurred by Employer if all the requested information is not furnished within the time period set forth in this paragraph.
- 4. Reliance on Employer Provided Information. All information supplied to CBIZ by Employer shall be provided in writing or in such electronic media as is acceptable to the parties and such information shall be true and correct to the best of Employer's belief and knowledge. CBIZ may rely on any such information furnished by authorized individual(s) of Employer and shall have no responsibility to inquire into its correctness or accuracy. CBIZ shall incur no liability for reliance on such information in the performance of its services. If the information supplied proves to be incorrect, Employer will, if applicable, pay CBIZ based upon then current hourly rates for the costs of all work to correct such information. Employer shall use reasonable efforts to retain duplicate copies of information or material sent to CBIZ and for taking other precautions as it deems necessary in case such information or materials are lost or destroyed, regardless of cause, or in case information reprocessing is needed for any reason.
- 5. <u>Plan Administration and Fiduciary Responsibilities</u>. Employer is the Plan's fiduciary, whether named or otherwise, and plan administrator, not CBIZ. Nothing contained in this Agreement shall be deemed to make CBIZ a fiduciary to the Plan. Employer is solely responsible for all administrative duties incident to the maintenance of the aforementioned Plan, including general compliance with the Consolidated Omnibus Budget Reconciliation Act of 1985, P.L. 99-272 ("COBRA") or any other federal, state or local laws or regulations that may have bearing on this Plan.

CBIZ, its officers, employees and agents are not Plan fiduciaries and shall not perform any functions which might, in the opinion of CBIZ, result in the classification of CBIZ, or any of its officers, employees or agents as a "fiduciary". Employer acknowledges that CBIZ has no discretionary authority, control or responsibility over the Plan or over the administration of Plan assets. CBIZ will execute requested transactions involving the Plan only after receiving the appropriate authority from Employer, named representative(s) or other properly identified fiduciary (ies).

CBIZ, its officers, employees and agents will not furnish any legal, tax, or accounting advice for which its officers, employees or agents are not licensed to furnish, but will direct such questions either directly to, or through Employer. Employer bears responsibility to direct such questions to its legal counsel and accountant.

From time to time in the course of providing the services hereunder, CBIZ has and will continue to provide Employer with independent industry data and information for Employer and its management to materially utilize in making decisions related to Employer's Plan. Employer will be responsible for management decisions and functions, and for designating an individual who possesses suitable skill, knowledge, and/or experience, preferably within senior management, to oversee any services CBIZ may provide. Employer is responsible for evaluating the adequacy and

results of the services performed and accepting responsibility for the results of such services; provided, however, the aforesaid shall in no way waive, release, obviate or mitigate the obligations, covenants, responsibilities and liabilities of CBIZ under this Agreement.

- 6. <u>Limitation of Liability</u>. CBIZ's services under this Agreement shall be limited to the services outlined on the Addendums attached hereto. Neither CBIZ, nor its officers, employees and agents shall have any liability whatsoever for the payment of any damages, interest, taxes, fines or penalties which arise out of or are in connection with any acts or omissions of a Plan trustee, sponsor, fiduciary, administrator or party-in-interest to the Plan.
  - CBIZ's liability regarding processing and recordkeeping errors shall be limited only to substantiated and proven direct damages and the correction of such errors that are reported to CBIZ within thirty (30) days of receipt of said erroneous reports, records or information by Employer. In no event will the amount of any damages exceed the amount of the fees that have been paid by Employer to CBIZ in the immediately preceding twenty-four (24) month period. CBIZ shall not be liable for any indirect, punitive, special or consequential damages arising out of any breach of this Agreement.
- 7. Prior Acts or Omissions. CBIZ shall not be liable for any acts or omissions with respect to the services provided hereunder, which were committed before the date of this Agreement by another third party provider. CBIZ shall also not be liable for any acts or omissions with respect to the services provided hereunder for the Plan which occur after this Agreement's termination, except for acts or omissions in connection with the transfer of records upon termination of this Agreement as provided in Section 14 of this Agreement.
- 8. <u>Indemnification</u>. Subject to the limitations stated in Section 6 above and notwithstanding any other provision to the contrary, each party to this Agreement (the "Indemnifying Party") agrees to indemnify and hold harmless the other party (the "Indemnified Party") and its officers, directors, employees, agents and affiliates from and against any and all loss, liabilities, demands, claims, actions and expenses (including, without limitation, any attorneys' fees and taxes) arising out of, or in connection with, any breach of the Indemnifying Party's responsibilities under this Agreement which are found to constitute gross negligence or willful misconduct. The provisions of this Section shall survive termination of this Agreement for a period not to exceed three (3) years from the date of termination of this Agreement, and shall be binding on the parties' successors and assigns.
- 9. <u>Fees.</u> The fees for CBIZ's services performed hereunder shall be outlined on Addendum B, attached hereto and made a part hereof.
- 10. Confidentiality. Each party agrees not to disclose or use during or subsequent to termination of this Agreement, any confidential information relating to the other party's business unless such use is required in the performance of this Agreement. The parties agree and understand that confidential information is any information that is treated as confidential by either party and/or has not been made generally available to the public. Such information shall include, but not be limited to, employee information, client and customer lists, data, records, computer programs, manuals, reports, processes and methods that each party may have become privileged to during the course of this Agreement. All records and other materials related in any way to each party's business shall be and remain the respective party's property during and after the termination of this Agreement. Upon termination of the Agreement, each party shall promptly return to the other party all copies of materials involving confidential information in the other party's possession or control. The parties further agree and acknowledge that they will disclose the confidential information only to those directors, officers or employees that have an absolute need to know for the purposes of the Agreement. A copy of CBIZ's privacy practices regarding Employer's nonpublic personal information is available upon request. The provisions of this Section 10 shall survive the termination of this Agreement.
- 11. <u>Authorization to Disclose Employer Information</u>. Employer authorizes CBIZ to share Employer information with other CBIZ affiliated companies for the limited purpose of providing other services for Employer by a CBIZ affiliated company. Employer further authorizes CBIZ to provide Employer information to approved third party vendors who are providing services for Employer; however CBIZ will not disseminate any information to any third party unrelated to CBIZ without Employer's written authorization. Employer agrees to indemnify and hold harmless CBIZ, its officers, directors, employees and agents against any loss, liabilities, demands, claims, actions and expenses arising out of or in connection with CBIZ providing information to any third party as authorized by Employer and provided for in this Section.

- 12. Ownership of CBIZ Intellectual Property. CBIZ shall retain all rights, title to and interest in any and all intellectual property developed in connection with the provision of services and relationship contemplated by this Agreement. For purposes of this Agreement, intellectual property shall include, but not be limited to, computer software, source code and written processes and procedures.
- 13. <u>Notice</u>. Any notice required or permitted to be given under this Agreement shall be sufficient if in writing and sent by registered mail, postage prepaid, addressed as follows:

If any party gives written notice of a change in address, notice to that party shall thereafter be given at the new address set forth in the notice.

- 14. Term and Termination. This agreement is effective October 14, 2019 and will remain in effect for a twelve (12) month period from and after the effective date stated (the "Initial Term"). Thereafter, this Agreement shall automatically renew for additional twelve (12) month terms (each a "Renewal Term"), unless terminated earlier by CBIZ or Employer with written notice ninety (90) days prior to the end of the Initial Term. In the event the Agreement is renewed for any Renewal Term(s), the Agreement may be terminated by either party with written notice ninety (90) days prior to the end of any Renewal Term. Notwithstanding anything stated herein to the contrary, either party may terminate this Agreement at any time upon an event of breach or default by the other party of any material term of this Agreement. Each party shall be given prompt notice of such breach or default by the other party and shall have thirty (30) days from the date of receipt of such notice to remedy and cure such default or breach. If, after such thirty (30) day period, the default or breach has not been remedied or cured, the Agreement will terminate. Upon termination, CBIZ shall have a reasonable amount of time to transfer account records information in accordance with the written instructions of Employer. CBIZ shall be entitled to receive all of the revenue due through the end of any term of the Agreement plus reasonable costs related to termination, including without limitation costs of generating termination related reports and accounting. CBIZ shall have no responsibility to release any records, plan data, electronic files or other information to Employer until CBIZ has received payment in full for any compensation due and owing to CBIZ pursuant to this Section and Section 9 above for services performed prior to termination of this Agreement.
- 15. <u>Amendment</u>. The terms and provisions of this Agreement and the attached Addendums may be modified or amended only by written agreement executed by the parties hereto.
- 16. <u>Waiver</u>. No waiver of any breach of this Agreement shall constitute a waiver of any other breach, whether of the same or any other terms of this Agreement, nor shall any delay or omission of either party's exercise of any right arising from any default affect or impair the party's rights as to the same or future default.
- 17. <u>Severability</u>. In case any provision of this Agreement is invalid or unenforceable, the validity and enforceability of the Agreement's remaining provisions shall not in any way be affected or impaired.
- 18. <u>Successor and Assigns</u>. This Agreement and all Addendums shall inure to the benefit of and be binding upon the parties hereto, their successors and assigns. However, this Agreement shall not be assigned to any other party without the other party's written consent.
- 19. Governing Law. This Agreement shall be governed by and construed under the laws of the State of Ohio, without regards to principles of conflicts of laws. Both parties to this Agreement hereby irrevocably submit to the jurisdiction of the courts of the state of Ohio (state or federal), with venue in Cuyahoga County, over any dispute arising out of this Agreement and agree that all claims in respect of such dispute shall be determined in such court.

- 20. Entire Agreement. This Agreement and all attached Addendum(s) contain the entire understanding between the parties with respect to the subject matter herein and supersedes any prior or contemporaneous written or oral agreement between them related to the subject matter hereof. There are no representations, agreements, arrangements or understandings, oral or written, between the parties relating to the subject matter of this Agreement, which are not fully expressed herein.
- 21. <u>Headings</u>. The headings in this Agreement are for convenience only and shall not be used to interpret or construe its provisions. All pronouns used in this Agreement shall be deemed to refer to the masculine, feminine or neuter gender as the context requires.
- 22. <u>Counterparts</u>. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

# Addendum A - Scope of Services

CBIZ RPS will determine the liabilities, expenses and all required supplementary information and notes to financials associated with the Employer's retiree healthcare plan. All work will follow Governmental Accounting Standards Board (GASB) Statements Nos. 74 & 75 and Public Act 202 of 2017, as applicable.

#### GASB Nos. 74 & 75

In determining the Employer's Total OPEB Liability ("TOL"), normal cost, Actuarially Determined Contributions ("ADC"), and financial statement information, as described under GASB standards, the following services will be performed:

#### Planning session

CBIZ RPS will contact the Employer's associates to review their program, in particular, discussing the substantive benefit plans as they pertain to retiree healthcare benefits. The review will address the valuation date, current number of eligible active and retired employees, current costs associated with the plan(s), historical cost increases, employee turnover, time line and other pertinent information.

#### Data collection and reasonableness review of data

CBIZ RPS will provide the Employer with a detailed data request, discuss all required data and establishing a mutually agreed timeline to supply all necessary data.

#### Review of actuarial assumptions

CBIZ RPS will determine and discuss with the Employer all assumptions including turnover, mortality, healthcare trend, morbidity, retirement rates, spousal rates, starting per-capita healthcare costs, discount rate and investment return. Discussions will include the *Uniform Assumptions*, released annually by the Michigan Department of the Treasury. Once the assumptions are approved by the Employer, the valuation will begin.

#### Review of investment and funding policies

In accordance with the discount rate calculation process under GASB Nos. 74 & 75, and development of the Actuarially Determined Contributions, CBIZ RPS will review any existing investment and funding policies for the Plan or recommend establishing formal policies to take advantage of funding methodologies.

#### Summary of liabilities and ADC at the valuation date

CBIZ RPS will summarize all liabilities with adequate supporting detail. The ADC for years within the valuation cycle will be determined. Examples will be used to illustrate the liability development process, as applicable.

#### Formal valuation and actuarial reports (provided once summary and draft results accepted)

CBIZ RPS will provide an Actuarial Valuation Report and Certification including all pertinent information and up to three (3) breakouts by group/division. CBIZ RPS will provide interim-year accounting disclosures for fiscal years within the valuation cycle upon conclusion of the fiscal year. These reports can be shared with all auditors and the general public.

#### Follow-Up and Support

Upon completion of each actuarial valuation, CBIZ RPS will discuss the results of the report and answer any questions or concerns from interested parties.







# Addendum A - Scope of Services (cont.)

#### Public Act 202 of 2017

CBIZ will calculate and disclose separate valuation results under the Public Act 202 of 2017 *Uniform Assumptions* as released annually by the State of Michigan Department of Treasury. An executive summary and disclosure of plan provisions and actuarial assumptions will accompany these results. For interim years in which "roll-forward" methods are used for GASB No. 75 accounting, adjustments will be made to liabilities and costs to account for changes in the *Uniform Assumptions*.

Should the actuarial assumptions used for financial reporting purposes under GASB Nos. 74 & 75 also comply with the *Uniform Assumptions* under Public Act 202 of 2017, a separate report would **not** need be provided.

## **Integrity and Independence Commitment**

The valuation will be performed according to generally accepted actuarial principles and practices and will follow all the guidelines promulgated by the Actuarial Standards Board. Such standards, in particular, pertain to health care liabilities, data integrity, and health care cost projections. Any deviation from a standard will be disclosed within the actuarial report and will include support for its use.

Hi Heather,

I'm not finding any specific direction from the State Tax Commission or the Attorney Generals Office on partial ownership of a house of worship and eligibility for the exemption. Let me say I'm not an attorney and can't offer legal advice. You may need to seek the advice of your own legal counsel. Ultimately you will need to make a determination to the best of your ability. Please remember that the responsibility to prove eligibility for the property tax exemption lies with the property owner. Your decision can be appealed by the property owner to the March Board of Review and then to the Michigan Tax Tribunal if the taxpayer disagrees with it.

Michigan Compiled Law (MCL) states:

211.7s Houses of public worship; parsonage.

Sec. 7s.

Houses of public worship, with the land on which they stand, the furniture therein and all rights in the pews, and any parsonage owned by a religious society of this state and occupied as a parsonage are exempt from taxation under this act. Houses of public worship includes buildings or other facilities owned by a religious society and used predominantly for religious services or for teaching the religious truths and beliefs of the society.

I discussed the issue with my peers and we are in agreement that 'a' religious society indicates ownership by the religious society alone. We believe the same would also apply to MCL 211.70 for charitable organizations. MCL 211.7s does not provide for partial ownership in the same manner as it does for the Principal Residence Exemption (PRE) at MCL 211.7dd(3). . .

I have a question regarding the requirement for ownership of a church to be exempt from ad valorem property taxes. I have a church in The City of Swartz Creek that was sold in 2018. The new ownership of the property is Kerry Lockrey & Kay Lockrey and The Sanctuary of Swartz Creek, Inc., a Michigan Non-Profit Corporation. Does the joint ownership that includes individuals make them ineligible for the exemption? I am aware that the law says the church must own and occupy but cannot find anything that defines ownership as it pertains to this case. When I questioned them about this they stated that they have a mortgage on the property and the mortgage company required the property to be in the individuals name, therefore they can't make any changes to the ownership.


