SOLAR ORDINANCE DISCUSSION:

The purpose is to discuss PA 233, (HB 5120), enacted by the State in 2023 regarding the signing of alternative energy systems (solar, wind and battery). This bill does not take effect until November 29, 2024.

We have four options: 1) do nothing; 2) adopt a CREO (compatible renewable energy ordinance); 3) oppose it; 4) add a sentence or two to the ordinance that says "All projects will be reviewed by the Michigan Public Service Commission."

Included in the packet is the draft language, which includes four different sections: Definitions, Accessory Scale Energy Systems, Large Principal Scale Energy Systems, and Small Principal Scale Energy Systems.

Discussion ensued between City Council and CIB Planning.

Motion to move the next Planning Commission meeting to Wednesday, November 6, 2024, to avoid election day, for a public hearing.

Commissioner Grimes doesn't believe there is any farmland left in Swartz Creek.
