IX. INSTRUCTIONS FOR COMPLETING APPLICATION

GENERAL: Mechanical work shall not be started until the application for permit has been filed. All installations shall conform with the Mechanical Code. **No work shall be concealed until it has been inspected.** When ready for an inspection, at least 1 day's notice is required. Permit number and address required.

PERMIT EXPIRATION: A permit remains valid provided work is progressing & inspections are requested & conducted. A permit shall become invalid if the authorized work is not commenced within 6 months after issuance or if work is suspended or abandoned for a period of six months after the time of commencement. A permit will be cancelled when no inspections are requested/conducted within six months of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.
